City of Cass Lake pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota

Municipal Board may review and comment, but shall within 30 days order the annexation

of land pursuant to said subdivision; and

WHEREAS, on September 12, 1997, the Minnesota Municipal Board has reviewed

and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Cass Lake, Minnesota, the same as if it had originally been made a part thereof:

That part of the Southwest Quarter of the Southwest Quarter (SW% of SW%), Section Fifteen (15), Township One-Hundred Forty-five (145) North of Range Thirty one (31) West, Cass County, Minnesota, described as follows:
