and Long Range Planning may review and comment, but shall within 30 days order the

annexation pursuant to said subdivisions; and

WHEREAS, on August 12, 2004, the Director has reviewed and accepted the resolution

for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of St. Joseph, Minnesota, the same as if it had originally been made a part thereof:

That part of the Southwest Quarter of the Northwest Quarter (SW 1/4 NW 1/4), Section 15, Township 124 North, Range 29 West, Stearns County, Minnesota which lies south of the following described line; commencing at the southwest corner of said Southwest Quarter of the Northwest Quarter (SW 1/4 NW 1/4); thence North 01 degrees 43 minutes 07 seconds West along the west line of said Southwest Quarter of the Northwest Quarter (SW 1/4 NW

1/4) 853.85 feet to the point of beginning of the line to be described; thence

<u>North</u> <u>East</u> <u>South</u> 88 degrees 16 minutes 54 seconds West-643.79 feet more or less to the west line of ST. JOSEPH CEMETARY, according to the recorded plat thereof, Stearns County, Minnesota, and there terminating. LESS AND EXCEPT that part of said SW 1/4 NW 1/4 previously annexed.

- 2. The North 200.00 feet of the West 150.00 feet of the Northwest Quarter of the Southwest Quarter (NW 1/4 SW 1/4), Section 15, Township 124 North, Range 29 West, Stearns County, Minnesota.
- 3. All of REISCHL'S HILLSIDE ESTATES except Lot 1, Block One, according to the recorded plat thereof, Stearns County, Minnesota together with that part of 295th Street which lies contiguous and north of said REISCHL'S HILLSIDE ESTATES.
