WHEREAS, a joint resolution for orderly annexation was adopted by the City of Monticello and the Town of Monticello; and

WHEREAS, an amendment to the joint resolution was received from the City and Town of Monticello indicating their desire that certain property be annexed to the City of Monticello pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325, M.S. 414.11, and M.S. 414.12 states that in certain circumstances the Director of the Office of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on October 1, 1999, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Monticello, Minnesota, the same as if it had originally been made a part thereof:

thence North 63 degrees 33 minutes 18 seconds East 100.80 feet; thence North 64 degrees 44 minutes 47 seconds East 62.10 feet; thence North 31 degrees 40 minutes 19 seconds West 302.49 feet; thence northwesterly 381.72 feet along a tangential curve, concave to the southwest, having a radius of 500.00 feet and a central angle of 43 degrees 44 minutes 30 seconds; thence North 75 degrees 24 minutes 49 seconds West, tangent to last described curve, 102.75 feet; thence North 14 degrees 35 minutes 11 seconds East 80.00 feet; thence South 75 degrees 24 minutes 49 seconds East 621.61 feet to the intersection of the east line of said South Half of the Southeast Quarter of Section 10; thence South 0 degrees 12 minutes 48 seconds West, along said east line, 861.29 feet to the point of beginning.
