IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Hamburg, Minnesota, the same as if it had originally been made a part thereof:

Part of the Northeast Quarter of the Northeast Quarter of Section 32,

Township 115, Range 26, Carver County, Minnesota, described as follows: Commencing at the northeast corner of Section 32; thence on an assumed bearing of South 00 degrees 00 minutes 00 seconds west along the east line of said Northeast Quarter 214.50 feet to the point of beginning of the tract to be described; thence continuing South 00 degrees 00 minutes 00 seconds west along said east line 346.50 feet; thence north 90 degrees 00 minutes 00 seconds west 35.00 feet; thence north 90 degrees 00 minutes 00 seconds west 216.50 feet; thence north 00 degrees 00 minutes 00 seconds west 216.50 feet; thence north 89 degrees 49 minutes 54 seconds east 441.98 feet; thence north 89 degrees 00 minutes 00 seconds west 61.50 feet; thence north 89 degrees 49 minutes 54 seconds east 253.50 feet to the point of beginning. This tract contains 3.12 acres of land.
