WHEREAS, said orderly annexation agreement designates five (5) parcels for future annexation, and


WHEREAS, the necessary criteria for annexation of parcels in Exhibit A in the Joint Resolution for Orderly Annexation have been met.

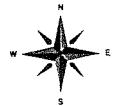
