AGREEMENT BETWEEN THE CITY OF ZIMMERMAN) ORDER
AND THE TOWN OF LIVONIA PURSUANT TO)
MINNESOTA STATUTES 414)

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Zimmerman and the Town of Livonia; and

WHEREAS, a resolution was received from the City of Zimmerman indicating their desire that certain property be annexed to the City of Zimmerman pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on May 25, 1999, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Zimmerman, Minnesota, the same as if it had originally been made a part thereof:

Section 16, T34, R26: The South half of Section 16 lying West of the Southwesterly line of the Highway 169 right-of-way and lying East of the westerly


line of former Burlington Northern Railroad right-of-way; and that part of the SW1/4 of SE1/4 lying west of the easterly line of the former Burlington Northern Railroad right-of-way; and Section 17, T34, R26: North ½ of SE 1/4 except South 240 feet of East 907.60 feet of NE 1/4 of SE 1/4, and west ½ of SW 1/4, Section 17; and Section 18, T34, R26: East ½ of NE 1/4 except North 300 feet of East 363 feet of NE 1/4 of NE 1/4 and except West ½ of NW 1/4 of NE 1/4 of NE 1/4; and North ½ of SE 1/4 except E 544.50 feet lying South of North 560 feet of NE 1/4 of SE 1/4; and Section 21, T34, R26: NW 1/4 of NE 1/4, Section 21.

IT IS FURTHER ORDERED: That the effective date of this order is May 25,

1999.
