JOINT RESOLUTION 99-1 OF THE CITY OF GREEN ISLE, THE TOWNSHIP OF WASHINGTON LAKE, AND THE TOWNSHIP OF GREEN ISLE, PURSUANT TO MINNESOTA STATUTES 414.0325, SUBDIVISION 1, DESIGNATING CERTAIN UNINCORPORATED LAND AS IN NEED OF ORDERLY ANNEXATION, CONFERRING JURISDICTION ON SAID LAND TO THE MINNESOTA MUNICIPAL BOARD, AND AGREEING TO IMMEDIATE ANNEXATION OF SAID LAND TO THE CITY OF GREEN ISLE.

WHEREAS, The City of Green Isle and the Townships of Washington Lake and Green Isle, Sibley County, Minnesota, have received a petition by all of the owners of certain unincorporated land, as described herein, for designation as an area in need of orderly annexation and for the immediate annexation of said land to the City of Green Isle, and

WHEREAS, said land adjoins the City of Green Isle, and the parties agree said property is urban or about to become urban in character, is proposed to be developed for residential, business, and industrial expansion by the City of Green Isle, and the City of Green Isle is capable of providing city utility services, fire and police protection to said area within a reasonable time, and

WHEREAS, it is deemed appropriate and in the best interests of both the City of Green Isle and the Townships of Washington Lake and Green Isle that said land be annexed to the City of Green Isle.

NOW, THEREFORE, pursuant to Minnesota Statutes 414.0325, Subdivision 1, it is JOINTLY RESOLVED and agreed by the City Council of the City of Green Isle and the Board of Supervisors of the respective Townships of Washington Lake and Green Isle, Sibley County, Minnesota, as follows:

- 1. That the lands described at Appendix A attached hereto, including all streets, roads or alleys passing through said land, as shown on the map of said land attached hereto and made a part hereof, is properly subject to orderly annexation under and pursuant to Minnesota Statutes 414.0325, Subdivision 1, and is hereby designated as in need of orderly annexation as provided by statute.
- 2. The jurisdiction is hereby conferred upon the Minnesota Municipal Board over the provisions contained in this Joint Resolution.
- 3. That upon order of the Minnesota Municipal Board, the land described herein, including all streets, roads or alleys passing through said land as shown on the map of the land attached hereto and made a part hereof shall be annexed to and become part of the corporate municipal limits of the City of Green Isle.
- 4. That the area of the land to be annexed contains approximately <u>252.99</u> acres, and is proposed to be developed for residential and commercial purposes.

- 5. That the property taxes on the annexed land due and payable in 1999 shall be payable respectively to the Townships of Washington Lake and Green Isle according to the present township levies on said lands. Thereafter, property taxes on the annexed lands shall be payable to the City of Green Isle. However, as additional consideration, the City of Green Isle has agreed to pay to the Township of Washington Lake a lump sum payment of \$2500.00 no later than December 31, 1999, as a one time reimbursement payment for future lost taxes on the annexed parcels.
- 6. The electric utility service notice, as required by Minnesota Statute 414.0325, Subdivision 1A, has been satisfied. The City of Green Isle is not an electric utility service provider, and there will be no change in electric service or cost to the annexed parcels as a result of this annexation.
- 7. That no alteration of the stated boundaries is appropriate, no conditions for the annexation are required and no consideration by the Municipal Board is necessary. Upon receipt of this Joint Resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation in accordance with the terms of this resolution.

Washington Lake Township property:
