WHEREAS, a joint resolution for orderly annexation was adopted by the City of Medford and the Town of Medford; and

WHEREAS, a resolution was received from the City of Medford indicating their desire that certain property be annexed to the City of Medford pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation pursuant to said subdivisions; and

WHEREAS, on May 9, 2003, the Director has reviewed and accepted the resolution for orderly annexation;


IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Medford, Minnesota, the same as if it had originally been made a part thereof:

Commencing at the NE corner of Sublot 4 in the SW ¼ of Section 9, Township 109, Range 20, thence West along the North line of said Lot, 625 feet; thence South to the

South line of said Lot a distance of 297 feet more or less; thence East 625 feet more or less to a point 297 feet South of the Northeast Corner of said Sublot 4; thence North a distance of 297 feet more or less to the Northeast Corner of said Sublot 4. Together with a perpetual easement for road purposes over and across the North 16 ½ feet of that part of Sublot 4 in the Southwest Quarter of Section 9, Township 108, Range 20, lying East of the Chicago and Rock Island and Pacific Railway right of way, excepting, however, the East 500 feet thereof. All in Steele County, Minnesota.


