The Township of Hendrum and the City of Hendrum hereby jointly agree to the following:

1. That the following described area in Hendrum Township is subject to orderly annexation pursuant to M.S.A. § 414.0325, and the parties hereto designate the area described in the attached Exhibit A for orderly annexation. No alteration of the described boundaries is appropriate.

2. That the Township of Hendrum does, upon passage of this resolution and its adoption by the City Council of the City of Hendrum, Minnesota, and upon acceptance by the Municipal Board, confer jurisdiction upon the Minnesota Municipal Board over the various provisions contained in this agreement.

3. Certain properties abutting the City of Hendrum are presently urban or suburban in nature or are about to become so. Further, the City of Hendrum is capable of providing services to this area within a reasonable time and the annexation would be in the best interests of the area proposed for annexation. Therefore, the properties as described in the attached Exhibit A would be immediately annexed to the City of Hendrum.

4. Houston Engineering, Inc. made the enclosed map of the City of Hendrum in conjunction with the city's construction of a levee (dike). The parties agreed to annex the land where the levee was installed plus any land which is between the levee and the current city boundaries.

5. Utility charges will not change in the annexed area since both parties have the same service provider, namely: Red River Valley Co-op Power Association (REA).

6. No consideration by the board is necessary.
