WHEREAS, a joint resolution for orderly annexation was adopted by the City of Moorhead and the Towns of Moorhead and Oakport; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Moorhead pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325, M.S. 414.11, and M.S. 414.12 states that in certain circumstances the Director of the Office of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on December 3, 1999, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Moorhead, Minnesota, the same as if it had originally been made a part thereof:


Parcel 1: The Northeast Quarter of the Southwest Quarter of Section 3, Township 139 N, Range 48 W (Moorhead Township), Clay County, Minnesota. Said tract contains 40 acres more or less. Parcel 2: The Eastern 140 feet of the

Northwest Quarter of Section 3, Township 139 N, Range 48 W (Moorhead Township), Clay County, Minnesota. Said tract contains 8.4 acres more or less. Parcel 3: The South Half of the Southwest Quarter of Section 34, Township 140 N, Range 48 W (Oakport Township), Clay County, Minnesota. Said tract contains 80 acres more or less. Parcel 4: The Eastern 140 feet of the Northwest Quarter of Section 34, Township 140 N, Range 48 W (Oakport Township), Clay County, Minnesota. Said tract contains 8.4 acres more or less. Parcel 5: (28<sup>th</sup> Street Right-of-way) The Western 33 feet of the Northwest Quarter of Section 34, Township 140 N, Range 48 W (Oakport Township), Clay County, Minnesota. Said tract contains 2 acres more or less.

IT IS FURTHER ORDERED: That the effective date of this order is December 3, 1999.
