WHEREAS, on April 14, 2000, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:

All that part of the NW1/4, Section 33-T103N-R18W, Mower County, Minnesota;

described as follows:

Commencing at the southwest corner of the NW1/4 of said Section 33;

thence East a distance of 2628 feet more or less, on the south line of said NW1/4, to the southeast corner thereof;

thence North a distance of 1332 feet more or less, on the east line of said NW1/4, to a point on the centerline of County State Aid Highway No. 27;

thence West and Northwesterly a distance of 2995 feet more or less, on the centerline of said County State Aid Highway No. 27, to a point 254.5 feet east of the west line of said NW1/4;

thence South a distance of 513 feet, on a line parallel with and 254.5 feet east of the west line of said NW1/4;

thence West a distance of 254.5 feet, on a line parallel with and 513 feet south of the north line of said NW1/4, to a point on the west line thereof;

thence South a distance of 2118 feet more or less, on the west line of said NW1/4, to the point of beginning.
