JOINT RESOLUTION OF THE CITY OF FULDA AND OF THE TOWN OF BONDIN, COUNTY OF MURRAY, STATE OF MINNESOTA, DESIGNATING CERTAIN TERRITORY SITUATED WITHIN SAID TOWN AS IN NEED OF ORDERLY ANNEXATION AND REQUESTING IMMEDIATE ANNEXATION THEREOF.

WHEREAS, it is anticipated by the Town of Bondin and the City of Fulda that the following described territory:

SEE ATTACHED EXHIBITS

having a population of approximately 40 persons living in single-family dwellings and will ultimately become or has become urban or suburban in nature; and

WHEREAS, an orderly annexation will best provide for anticipated growth and municipal service needs of the whole community, including the city and the township; and

WHEREAS, the owners of a majority of the property affected have indicated to both the city and the town that they are in favor of an orderly annexation and are in need of the services to be provided thereunder; and

WHEREAS, the City of Fulda owns and operates the only central sanitary sewage collection and treatment system in the area herein under consideration and the city's facilities have the capacity to serve the territory proposed for immediate annexation and it is feasible to make the necessary extensions; and

WHEREAS, the City of Fulda owns and operates the only central water system in the area herein under consideration and its system has capacity to provide service to the territory proposed for immediate annexation and it is feasible to make the necessary extensions;

WHEREAS, the City of Fulda has demonstrated its willingness to proceed with a program to make such extensions and provide services to the territory proposed for immediate annexation; and

WHEREAS, the City of Fulda Fire Department serves the territory proposed for immediate annexation; and

WHEREAS, in addition to those services already described, the City of Fulda provides a full range of municipal services, including police protection, street maintenance, street lighting, and garbage collection and disposal and the benefits of these services would be extended to the territory proposed for immediate annexation immediately upon such annexation and the City of Fulda has demonstrated its willingness to proceed with a program to provide such services to the territory immediately upon such annexation;

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

1. That the Town Bondin and the City of Fulda hereby designate the attached described territory to be in need of immediate orderly annexation pursuant to and in accordance with Minnesota

Statutes § 414.0325.

- 2. That upon annexation the City of Fulda agrees to provide all services to citizens of the designated area that it provides to its current citizens.
- 3. That upon annexation the City of Fulda agrees to provide maintenance of the roadway, commonly known as South Lafayette Avenue, through the territory proposed for immediate annexation as indicated on the attached map and to further provide maintenance of said roadway south of the existing Mailander property to the boat landing.
- 4. That upon annexation the City of Fulda agrees to install the culvert that was planned and that the Town of Bondin had intended to install.
- 5. That upon annexation both the City of Fulda and the Town of Bondin agree to adopt whatever regulations and further resolutions deemed necessary to give full effect to the terms of this joint resolution.
- 6. That should a dispute arise as a result of the interpretation of terms contained in this joint resolution, such dispute shall first be attempted to be resolved by negotiation between the City of Fulda and the Town of Bondin and should such fail, the matter shall then be subject to mediation by a mediator jointly agreed upon.
- 7. That in providing for annexation of the designated area, no consideration by Minnesota Planning is necessary and no alteration of the agreed-upon boundaries is appropriate and all conditions for annexation have been stated in this joint resolution and that Minnesota Planning may review and comment, but shall, within 30 days of receipt of this joint resolution, order the annexation.
- 8. That the interpretation of this joint resolution shall be governed by the laws of the State of Minnesota.
- 9. That in the event one or more terms of this agreement shall be found invalid or unenforceable, the remainder of the agreement terms shall continue in full force and effect.
