WHEREAS, a joint resolution for orderly annexation was adopted by the City of Belle Plaine, and the Towns of Blakeley and Faxon; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Belle Plaine pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 , M.S. 414.11 , and M.S. 414.12 states that in certain circumstances the Director of the Office of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on July 12, 2001, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the resolution to the City of Belle Plaine, Minnesota, the same as if it had originally been made a part thereof:
