WHEREAS, on November 9, 2001, the Director of theUOffile of Strategic and FILED
Long Range Planning has reviewed and accepted the resOlution in far orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the resolution to the City of Lend, Minnesota, the same as if it had originally been made a part thereof:
