JOINT RESOLUTION
FOR ORDERLY ANNEXATION

The Township of Hartford and the City of Browerville hereby jointly agree to the following:

1. That the following described area in Hartford Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to wit:

The East 70 rods of the Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4), Section Nine (9), Township One Hundred Thirty (130) North, Range Thirty-three (33) West of the Fifth P.M., according to the United States Government Survey thereof, EXCEPT the South ten (10) acres of the said East 70 rods of Section 9, Township 130 North, Range 33 of the NW 1/4 of the NW 1/4, and EXCEPT the following: Commencing at the Northeast corner of the South 10 acres of the East 70 rods of the NW 1/4 NW 1/4 of Sect. 9, Township 130, Range 33; thence West parallel with the South line of said NW 1/4 NW 1/4 and along the North line of said South 10 acres of the said East 70 rods, a distance of 20 rods; thence North parallel with the East line of said NW 1/4 NW 1/4 a distance of 16 rods; thence East parallel with the North line of said South 10 acres of the said East 70 rods a distance of 20 rods to the East line of said NW 1/4 NW 1/4; thence South and along the East line of said NW 1/4 NW 1/4 a distance of 16 rods to the place of beginning.

2. Upon annexation, the zoning shall be agricultural (A-O).

3. Both the Town of Hartford and the City of Browerville agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.

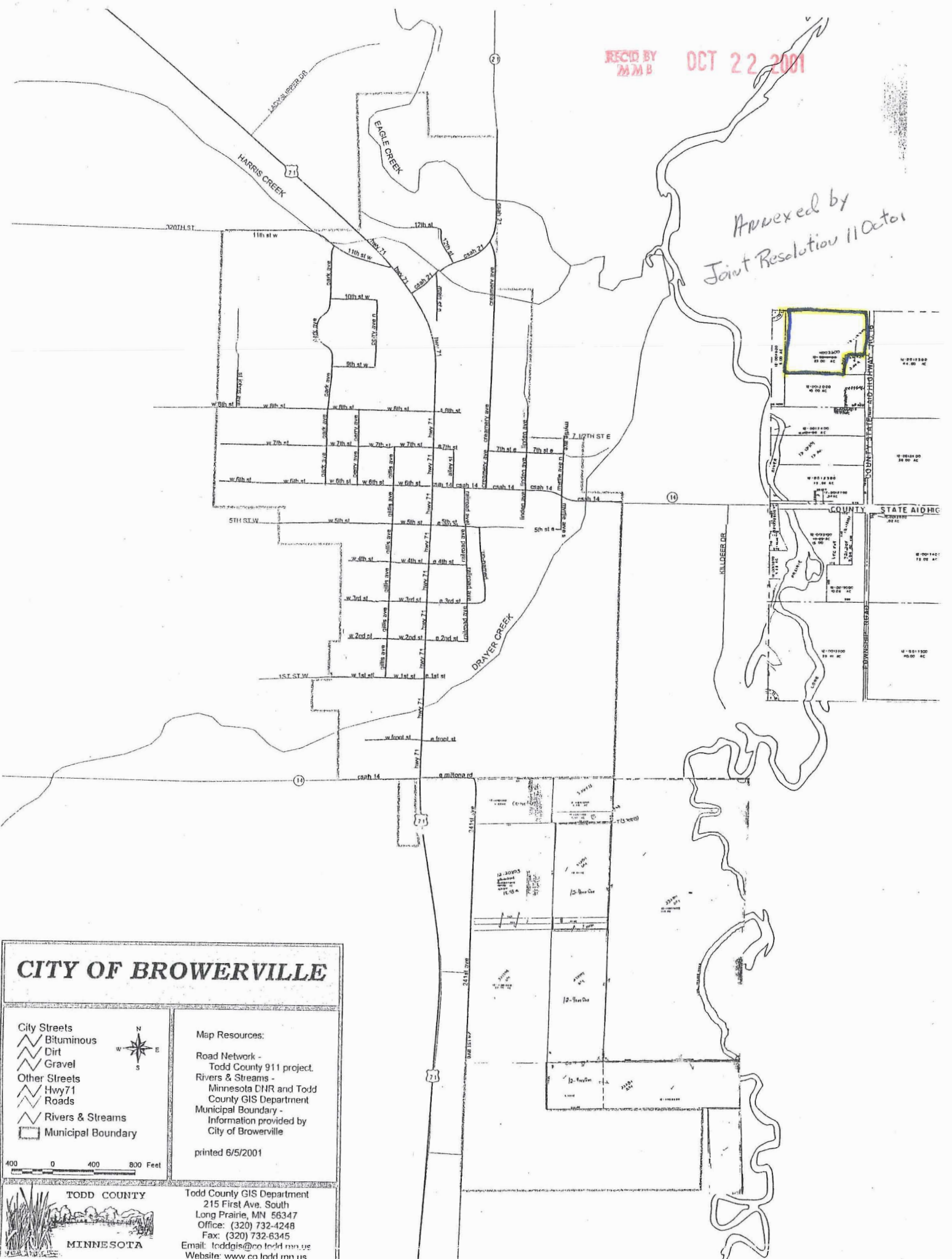

CITY OF BROWERVILLE

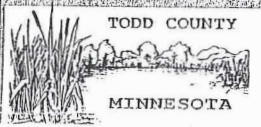
