## IN THE MATTER OF THE ORDERLY ANNEXATION ) AGREEMENT BETWEEN THE CITY OF GOODVIEW , AND THE TOWN OF ROLLINGSTONE PURSUANT TO ) <br> ORDER MINNESOTA STATUTES 414

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Goodview and the Town of Rollingstone; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Goodview pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on July 18, 2003, the Acting Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Goodview, Minnesota, the same as if it had originally been made a part thereof:

That part of the Northwest Quarter of the Southwest Quarter (NW $1 / 4$ of $S W 1 / 4$ ) of Section Twelve (12), Township'One Hundred Seven (107) North, of Range Eight (8), West of the Fifth Principal Meridian, Winona County, Minnesota, described as follows:

Commencing at the Southwest corner of the $\mathrm{N} 1 / 2$ of the $\mathrm{SW} / 4$ or said Section 12; thence in an Easterly direction along the South tine of the $\mathrm{N} 1 / 2$ of the SW $1 / 4$ of said Section 12, a distance of 1149.7 feet; thence deflect to the left $124^{\circ} 06^{\prime}$, a distance of 83.6 feet; thence deflect to the left $2^{\circ} 06^{\prime}$, a
distance of 92.2 feet; thence cloflect to the left of $1^{\prime \prime} 52^{\prime}$, a distance of 151.8 feet; thence deflect to the left $1^{\circ} 47^{\prime}$; a distance of 20.4 feet; thence deflect to the left $90^{\circ}$, a distance of 50 feet; thence cleflect to the right $90^{\circ}$, a distance of 75 feet to the point of beginning; thence deflect to the left $90^{\circ}$. a distance of 150 feet; thence deflect to the right $39^{\circ} 51^{\prime}$, a distance of 17.9 feet; thence deflect to the right $90^{\circ}$, a distance of 164.8 feet; thence deflect to the right $90^{\circ}$, a distance of 75 feet; thence deflect to the right $49^{\circ} 24^{\prime}$, a distance of 33.2 feet; thence deflect to the right $0^{\circ} 45^{\prime}$, a distance of 56.8 feet, more or less, to the point of beginning.

Also, That part of the Northwest Quarter of the Southwest Quarter (NW $1 / 4$ of SW $/ 4$ ) of Section Twelve (12), Township One Hundred Seven (107) North, of Range Eight (8), West of the Fifth Principal Meridian, Winona County, Minnesota, described as follows:

Commencing at the Southwest corner of the $\mathrm{N} 1 / 2$ of the $\mathrm{SW} 1 / 4$ of said Section 12; thence in an Easterly direction and along the South line of the $\mathrm{N} / 2$ of the SW $1 / 4$ of said Section 12, a distance of 722.21 feet; thence deflect to the left $90^{\circ} 00^{\prime}$, a distance of 208.22 feet to the point of beginning; thence continue Northerly along last described course, a distance of 164.80 feet; thence deflect to the left $90^{\circ} 00^{\prime}$, a distance of 25.00 feet; thence deflect to the left $90^{\circ} 00^{\prime}$, a distance of 164.80 feet; thence deflect to the left $90^{\circ} 00^{\prime}$, a distance of 25.00 feet, more or less, to the point of beginning.
