A RESOLUTION ANNEXING PROPERTY FROM SPRING LAKE TOWNSHIP INTO
THE CITY OF PRIOR LAKE

CITY OF PRIOR LAKE RESOLUTION # 03-193

WHEREAS, this Joint Resolution designates an area in need of orderly annexation; provides for the conditions for its annexation; designates that no consideration by the Minnesota Office of Boundary Adjustment is necessary, but the Office may review and comment, but shall, within 30 days, order the annexation in accordance with the terms of this resolution; and reflects that the City of Prior Lake and Spring Lake Township hereby jointly agree to the following:

1. That the following described property in Spring Lake Township is subject to annexation pursuant to Minnesota Statutes 414.031 and the parties hereto designate this area for orderly annexation, to wit:

That part of Government Lot 5, Section 11, Township 114, Range 22, Scott County, Minnesota, lying west of the east 28 feet and east of the following described line: Beginning at a point on the north line of said Government Lot 5, distant 225 feet east of the northwest corner; thence southerly parallel with the west line of said Government Lot 5 to the shoreline of Crystal Lake and there terminating.

2. That the City Council of the City of Prior Lake and the Board of Supervisors of Spring Lake Township, upon passage and adoption of this resolution, and upon acceptance by the Minnesota Office of Boundary Adjustment, agree to the annexation of the aforementioned property into the City of Prior Lake.
3. That there is no change in electrical service provided for the subject annexation, therefore, State Statute 414.0235, Subd. 1 A, is not applicable.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PRIOR LAKE, SCOTT COUNTY, MINNESOTA, THAT: The City of Prior Lake approves the proposed annexation of the aforementioned property from Spring Lake Township into the City of Prior Lake.


