WHEREAS, a joint resolution for orderly annexation was adopted by the City of Cedar Mills and the Town of Cedar Mills; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Cedar Mills pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on October 13, 2003, the Acting Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Cedar Mills, Minnesota, the same as if it had originally been made a part thereof:

ALSO EXCEPTING all that part of the NW ¼ of SW ¼, Section 13 lying North of a line described as follows: Commencing at a point in the East line thereof, distant 252 feet South of the Northeast corner thereof, thence Northwesterly on a 2 degree left curve a distance of 963 feet, thence Westerly a distance of 426 feet to a point in the West line of said 1/4 section, distant 50 feet South of the Northwest corner thereof, containing 3.48 acres of land; the metes and bounds in describing the north boundary line of the above described parcel of land have been taken in accordance with the Quarter Section line of said Section 13 as the same is now established.
