IN THE MATTER OF THE ORDERLY ANNEXATION BETWEEN THE CITY OF GLENVILLE AND FREEMAN TOWNSHIP PURSUANT TO MINN. STAT. § 414.0325

WHEREAS, a request from all of the property owners of the area proposed for designation and immediate annexation was received.

WHEREAS, the City of Glenville and Freeman Township jointly agree to designate and request the immediate annexation of the following described land located within Freeman Township to the City of Glenville, County of Freeborn, Minnesota:

A parcel of land in the County of Freeborn, State of Minnesota, legally described in **Exhibit A** and shown on the Drawing of Annexation, both being attached hereto and incorporated herein.

WHEREAS, the City of Glenville and Freeman Township are in agreement as to the orderly annexation of the unincorporated land described; and

WHEREAS, Minn. Stat. § 414.0325 provides a procedure whereby the City of Glenville and Freeman Township may agree on a process of orderly annexation of a designated area; and

WHEREAS, the City of Glenville and Freeman Township have agreed to all the terms and conditions for the annexation of the above-described lands; and the signatories hereto agree that no alteration of the designated area is appropriate and no consideration by the Chief Administrative Law Judge is necessary. The Chief Administrative Law Judge may review and comment, but shall within thirty (30) days, order the annexation in accordance with the terms of the resolution.

NOW, THEREFORE, BE IT RESOLVED, jointly by the City Council of the City of Glenville and the Township Board of Freeman Township as follows:

- **Section 1. Property.** That the land described above is subject to orderly annexation pursuant to Minn. Stat. § 414.0325, and that the parties hereto designate the area for orderly annexation; and agree that the land be immediately annexed.
- **Section 2.** Acreage/Population/Usage. That the orderly annexation area consists of approximately 4.9 acres, the population in the area is 0, and the land use type is rural non-agricultural.
- **Section 3. Jurisdiction.** That Freeman Township and the City of Glenville, by submission of this joint resolution to the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, confers jurisdiction upon the Chief Administrative Law Judge so as to accomplish said orderly annexation in accordance with the terms of this resolution.

Section 4. Municipal Reimbursement. That Minn. Stat. § 414.036.

Freeman Township and the City of Glenville agree that there shall be no reimbursement. There is no tax-exempt property in the area to be annexed.

- **Section 5**. **Assessments and Debt.** That pursuant to Minn. Stat. § 414.036 with respect to any special assessment assigned by the Township to the annexed property and any portion of debt incurred by the Township prior to the annexation and attributable to the property to be annexed, but for which no special assessments are outstanding, for the area legally described (herein or attached exhibit) there are no special assessments or debt.
- **Section 6. Tax Rate Step Up.** That pursuant to Minn. Stat. § 414.035, the tax capacity rate applicable to the property after annexation shall be increased in substantially equal proportions over a period of 1 year to equality with the tax rate of property already within the city.
- **Section 7. Review and Comment.** The City of Glenville and Freeman Township agree that upon receipt of this resolution, passed and adopted by each party, the Chief Administrative Law Judge may review and comment, but shall within thirty (30) days, order the annexation in accordance with the terms of the resolution.




