## CITY OF WELLS, MINNESOTA CITY COUNCIL RESOLUTION NO. 2017-RESOLUTION OPPOSING PETITION FOR DETACHMENT ON CERTAIN PROPERTY FROM THE CITY OF WELLS

**WHEREAS**, the City of Wells is a statutory City under Minnesota Law located in Faribault County, Minnesota; and

**WHEREAS**, Dennis Lutteke and Diane Lutteke own certain property located within the corporate limits of the City of Wells legally described as follows:

The South Half of the Northwest Quarter of Section 4, Township 103 North, Range 24 West; together with the South 66.00 feet of the Northeast Quarter of the Northwest Quarter of Section 4, Township 103 North, Range 24 West; Faribault County.

WHEREAS, Dennis Lutteke and Diane Lutteke have brought a Petition for the Detachment of said property from the corporate limits for the City of Wells; and

**WHEREAS,** the above-described property was annexed into the City of Wells by its previous owner in 2003. The previous owner was a large industrial employer within the City and requested annexation for the purposes of potential plant expansion; and
