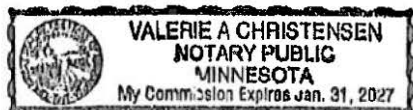
This Petition for Detachment is based upon the following:

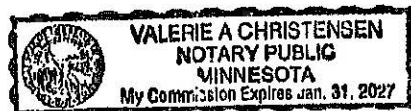
