JOINT RESOLUTION CITY OF PRIOR LAKE AND SPRING LAKE TOWNSHIP AMENDING THE ORIGINAL ORDERLY ANNEXATION AGREEMENT DOCKET #A-2148(OA)-2

A RESOLUTION ANNEXING PROPERTY FROM SPRING LAKE TOWNSHIP INTO THE CITY OF PRIOR LAKE

CITY OF PRIOR LAKE RESOLUTION # 03-101

WHEREAS, this Joint Resolution designates an area in need of orderly annexation; provides for the conditions for its annexation; designates that no consideration by the Minnesota Office of Boundary Adjustment is necessary, but the Office may review and comment, but shall, within 30 days, order the annexation in accordance with the terms of this resolution; and reflects that the City of Prior Lake and Spring Lake Township hereby iointly agree to the following:

1. That the following described property in Spring Lake Township is subject to annexation pursuant to Minnesota Statutes 414.031 and the parties hereto designate this area for orderly annexation, to wit:

The North 365,80 feet of the South 831,24 feet of the West 1190,81 feet of the South half of the Northeast Quarter (S 1/2 of NE 1/4) of Section 5, Township 114, Range 22, Scott County, Minnesota. Schneider

Subject to an easement for ingress and egress over that part of the South half of the Northeast Quarter (S 1/2 of NE 1/4) of said Section 5, described as follows: A strip of land twenty (20) feet in width the center line of which is described as follows:

Commencing at the Northwest corner of the South 831.24 feet of said South half of the Northeast Quarter; thence an assumed bearing of North 88 degrees 31' 59" East along the North line of said South 831.24 feet a distance of 498.00 feet to the point of beginning of the line to be described; thence South 70 degrees 41' 02" East a distance of 200.00 feet; thence South 89 degrees 08' 14" East a distance of 504.29 feet, more or less, to the East line of the West 1190.81 feet of said South half of the Northeast Quarter and there terminating. The side lines of the above described easement are to be shortened or extended as required to intersect the North and East boundaries of the first $\begin{tabular}{lll} \textbf{described property}. & (\texttt{commonly known as the Schneider property}) \\ \end{tabular}$

- 2. That the City Council of the City of Prior Lake and the Board of Supervisors of Spring Lake Township, upon passage and adoption of this resolution, and upon acceptance by the Minnesota Office of Boundary Adjustment, agree to the annexation of the aforementioned property into the City of Prior Lake.
- 3. That there is no change in electrical service provided for the subject annexation, therefore, State Statute 414.0235, Subd. 1 A, is not applicable.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PRIOR LAKE, SCOTT COUNTY, MINNESOTA, THAT: The City of Prior Lake approves the proposed annexation of the aforementioned property from Spring Lake Township into the City of Prior Lake.
