AGREEMENT BETWE	THE ORDERLY ANNEXATI EEN THE CITY OF PRIOR SPRING LAKE PURSUANT FES 414	LAKE)	ORDER	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Prior Lake and the Town of Spring Lake; and

WHEREAS, an amendment to the joint resolution was received from the City of Prior Lake and the Town of Spring Lake requesting that certain property be annexed to the City of Prior Lake pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on July 8, 1997, the Minnesota Municipal Board has reviewed and accepted the amendment to the joint resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Prior Lake, Minnesota, the same as if it had originally been made a part thereof:

The Northeast Quarter of the Northwest Quarter except the South 8.75 acres of Section 12, Township 114, Range 22, Scott County, Minnesota, according to the

U.S. Government Survey thereof; and

All that part of the Northeast Quarter (NE 1/4) lying south of the Chicago, Milwaukee and St. Paul Railroad Right-of-way; West Half (W 1/2) of the Northwest Quarter (NW 1/4); the South Eight and 75/100 (8.75) acres of the Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4); AND the Southeast Quarter of the Northwest Quarter (SE 1/4 of NW 1/4); All in Section Twelve (12), Township One Hundred Fourteen (114), Range Twenty-two (22), Scott County, Minnesota, EXCEPTING from the above Registered Land Survey Nos. 19, 98, 114 and 128; and

Tract E, Registered Land Survey No. 114, Files of the Registrar of titles, Scott County, Minnesota.

IT IS FURTHER ORDERED: That the population of the City of Prior Lake is hereby increased by 3.

IT IS FURTHER ORDERED: That the population of the Town of Spring Lake is hereby decreased by 3.

IT IS FURTHER ORDERED: That the effective date of this order is July 8, 1997.
