IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Waconia, Minnesota, the same as if it had originally been made a part thereof:

The portion of the following described tract lying within the Southwest Quarter of the

Northwest Quarter of Section 19, Township 116, Range 24: The North 72.67 acres of the South Half of the Northeast Quarter of Section 24, Township 116, Range 25 of the Southwest Quarter of the Northwest Quarter of Section 19, Township 116, Range 24, more particularly described as follows: Commencing at the northeast corner of the Southwest Quarter of the Northwest Quarter of Section 19, Township 116, Range 24; thence running West 50 chains to the northwest corner of the Southeast Quarter of the Northwest Quarter of Section 24, Township 116, Range 25; thence South 14 chains to a post; thence East 50 chains; thence North 14 chains to place of beginning. Which lies northerly of the South 18 acres of said Quarter Quarter.
