

RESOLUTION NO. 87-6

AMENDMENT TO THE JOINT RESOLUTION FOR
ORDERLY ANNEXATION BETWEEN THE LAKETOWN
TOWNSHIP AND THE CITY OF VICTORIA.

WHEREAS, Robert L. Helland, Trustee of Marital Trust for Grace C. McKnight, and Grace C. Lindley, also known as Grace C. McKnight, are sole owners in fee of the tract of land described below and made a part hereof and filed with the City of Victoria petition for annexation of said lands into the corporate limits of the City of Victoria.

NOW, THEREFORE, BE IT RESOLVED That the Laketown Township and the City of Victoria hereby jointly agree that the area designated for orderly annexation in the joint resolution between the Laketown Township and the City of Victoria, designating an area for orderly annexation dated March 16, 1972, and December 2, 1976 be amended to include the following:

Both the Laketown Township and the City of Victoria agree that no alteration of the stated boundaries of this agreement is appropriate.

FURTHERMORE, BE IT RESOLVED That both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation of the following described property:

The Northeast Quarter (NE1/4) of Section 23, Township 116 North, Range 24 West. Also, all of that part of the Northwest Quarter (NW1/4) of Section 24, Township 116 North, Range 24 West, lying westerly and southwesterly of the Centerline of Carver County State Aid Highway No. 11.

BE IT FURTHER RESOLVED, That by amending the original joint agreement, the City of Victoria and the Laketown Township are requesting that the Municipal Board, in this instance, not order any step-up in the mill levy; and


BE IT FURTHER RESOLVED That the City of Victoria shall accept the proposed annexed property into an rural mill rate and that any increase in that rural mill rate shall be dictated by the land use planning authority of the municipality in developing the property from a rural land use to an urban land use; and;

BE IT FURTHER RESOLVED That the Petition for Annexation of Robert L. Helland, Trustee of Marital Trust for Grace C. McKnight, and Grace C. Lindley, also known as Grace C. McKnight, shall become effective only upon approval of the MUSA (Metropolitan Urban Service Area) expansion to include said property described in said Petition for Annexation.





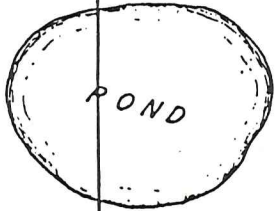
