WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation pursuant to said subdivisions; and

WHEREAS, on June 16, 2003, the Acting Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Isanti, Minnesota, the same

as if it had originally been made a part thereof:

Beginning at the intersections of the right-of-way of Isanti County Road 23 and 281st Street in Section 31, Township 35, Range 23, being inclusive of the right-of-way as platted, dedicated, and/or used and following said right-of-way in an easterly direction to the point of intersection with the centerline of Polk Street then northerly on the border of Section 31 and 32, Township 35, Range 23 following said centerline of Polk Street as platted, dedicated and/or used in a northerly direction to the intersection of the centerline of Townsedge Road, then easterly following the centerline of Townsedge Road in Section 32, Township 35, Range 23 as platted, dedicated and/or used to the westerly edge of Minnesota Trunk Highway 65 and there terminating. Said description to include all right-of-way as platted, dedicated and/or used as 281st Street, Polk Street and Townsedge Road within and adjacent to the route described above.

<u>MEMORANDUM</u>

In ordering the annexation contained in Docket No. A-2457(OA)-22 Isanti, the Acting Director of Strategic and Long Range Planning finds and makes the following comment:

Planning in the area designated for orderly annexation must be provided for by one of three provisions set forth in Minnesota Statutes Section 414.0325, Subd. 5. The joint resolution does not make reference to which of the three statutory provisions the parties have agreed on to govern planning in the designated area.

The parties are encouraged to consider this comment in light of any further amendments that may be otherwise necessary to this agreement for orderly annexation.
