

RESOLUTION NO. 90-05

IN THE MATTER OF THE AMENDMENT TO THE JOINT RESOLUTION
FOR ORDERLY ANNEXATION BETWEEN THE TOWN OF ISANTI AND
THE CITY OF ISANTI, MINNESOTA PURSUANT TO
MINNESOTA STATUTES 414.0325, SUBD. 1

The Town of Isanti and the City of Isanti hereby jointly agree that if, and in the event the Joint Resolution Between the Town of Isanti and the City of Isanti Designating an Area for Orderly Annexation filed with the Minnesota Municipal Board on August 31, 1973 (File No. A-2457 (OA) is still effective, then said agreement shall be amended to include the following:

Both the Town and the City agree that no alteration of the stated boundaries of said agreement is appropriate. Furthermore, both parties agree that pursuant to Minnesota Statutes 414.0325, Subdivision 1, no consideration by the Board is necessary for annexation of the following described territory to the City of Isanti. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within 30 days, order the annexation of the following described property in accordance with the terms of the joint resolution:

That part of the NE 1/4 of the NW 1/4 of Section 32, Township 35, Range 23, Isanti County, Minnesota, described as follows: Commencing at the Northwest corner of said NE 1/4 of NW 1/4, thence South along the West line of said NE 1/4 of NW 1/4 to a point 33 feet South of the North line of said NE 1/4 of NW 1/4, as measured at right angles to said North line; thence East and parallel to the North line of said NE 1/4 of NW 1/4 to the Westerly boundary line of Trunk Highway No. 65 as now located and established in said Township and Range; thence North following the westerly boundary of said Trunk Highway No. 65 to the North line of said NE 1/4 of NW 1/4, thence West along said North line to the point of commencement and there to terminate

That this amendment is solely intended to allow annexation of the above described territory to the City of Isanti without the necessity of Municipal Board consideration in the event the underlying Orderly Annexation Agreement is still effective. No other portions of said agreement, if still effective, shall be deemed modified in any way.



PROPOSED ANNEXATION - PALOMINO ROAD


