## IN THE MATTER OF THE ORDERLY ANNEXATION OF CERTAIN ADJOINING UNINCORPORATED TERRITORY TO THE CITY OF MONTGOMERY, MINNESOTA

Pursuant to M.S.A. 414.032, the Town Board of Montgomery Township and the Common Council of the City of Montgomery hereby jointly designate the hereinafter described unincorporated territory as in need of orderly annexation, and also hereby jointly confer jurisdiction over annexations in that area on the Minnesota Municipal Commission.

I.

This territory abuts on the City limits at the east boundary thereof, and none of it is presently a part of any incorporated City, Village, or Borough.

II.

This territory consists wholly of unplatted lands, all of which are or about to become urban or suburban in character. All said lands lie entirely with the County of Le Sueur, Minnesota, and may be described as follows:

> Commencing at that point at which the center line of the Chicago, Milwaukee, St. Paul & Pacific R.R. right-of-way intersects the east line of the  $SW_4$  of the NE4 of Sec. 10 in Twp. 111 N, Range 23 W. Le Sueur County, Minnespta; thence northeast along the aforesaid R.R. right-of-way to the centerline of Le Sueur County State Aid Road #26; thence west along said road center line to the NE corner of the NW4 of the NE4 of Sec. 10; thence south along the east line of the W2 of the NE4 of Sec. 10 in Twp. 111 N., Range 23 W. to the point of beginning.

III. The quanity of land embraced within the foregoing description, and bounded as described, is approximately forty (40) acres.
