IN THE MATTER OF THE ORDERLY ANNEXATION OF CERTAIN ADJOINING UNINCORPORATED TERRITORY TO THE CITY OF MONTGOMERY, MINNESOTA

WHEREAS, certain territory described below is not presently included within the incorporated limits of any city of village; and

WHEREAS, the Common Council of the City of Montgomery and the Town Board of Montgomery have by joint resolution declared the territory described below as subject to and in need of orderly annexation, and

WHEREAS, the territory described below is or is about to become urban or suburban in character:

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF MONTGOMERY:

1) The council hereby determines to annex the following territory to the City of Montgomery:

I.

Beginning at the NW corner of Section Eleven (11), Township One Hundred Eleven (111) North, Range Twenty three (23) West, thence Easterly 437.86 feet on the North line of said Section to the Northwesterly right-of-way line of the C.M.S. & P. R.R.; thence Southwesterly 505.41 feet at a deflection angle 135°17' right on the Right-of-way line of said Railway to the point of beginning of a spiral curve, thence Southwesterly 784 Feet more or less on said right-of-way line of said Railway on a spiral curve and  $1^{\circ}00$  circular curve to the left to the point of intersection of said curve with a line parallel to and 450 feet West of the East line of Section Ten (10), Township One Hundred Eleven (111) North Range Twenty Three (23) West, thence Northerly 940 feet more or less on said line to the North line of said Section Ten (10), thence Easterly 450.0 feet on said North line of said Section Ten (10) to the point of beginning being part of the Northeast Quarter of the Northeast Quarter (NE4 of NE4) of Section Ten (10) Township One Hundred Eleven (111) North, Range Twenty three (23) West and the Northwest Quarter of the Northwest Quarter (NW4 of NW4) of Section Eleven (11), Township One Hundred Eleven (111) North, Range Twenty Three (23) West, subject to highway easement on the North thirty three (33) feet thereof; less and excepting therefrom the following described tract in the North-east Quarter of the Northeast Quarter (NE4 of NE4) of Section Ten (10), Township One Hundred Eleven (111), Range Twenty three (23) West - a strip of land fifty (50) feet wide on the North (N) side of the right-of-way of the C.M.S. & P. R.R., commencing at Station 1407 on the said R.R. and running Easterly parallel to and adjoining said right-of-way to the East (E) line of said 1/4 1/4 Section.
