JOINT ANNEXATION RESOLUTION: PRATHERD-CROWN WIND TOOMSHIP

WEREAS, the Municipal Commission of the State of Minnesota presently has before it for hearing and consideration the matter of amazing certain particles of Grow Wing Township to the City of Brainard (Decket Ness A-2991 and A-3122); and,

WHERLAS, the Township of Grow Wing and the City of Brainerd are parties to the said bearings; and,

WERRAS, there is a basis for agreement between the parties to this action upon which the matters presently before the Minnesota Manicipal. Commission be settled, and the governmental parties hereto desire to set forth such terms of settlement by manus of this resolution.

NOW, THERETORIE, BE IT RESOLVED by the Township of Crow Wing and the City of Brainard, as follows:

- That the Township of Crow Wing does upon passage of this resolution and its adoption by the Council of the City of Brainord, withdraw its opposition to the pending annexation hearings (Municipal Countssion Docket Rusbors A-259) and A-3122) and joins with the city in requesting that the Municipal Countssion issue as order annexing cortain properties to the City of Brainord.
- 2. That, in addition to the properties involved in the present amounties proceedings, the Tunship of Grow Wing does hereby agree to parmit the City of Brainord to amount additional properties. The legal description for all of the properties to be amound by the City of Brainord pursuant to this Masslation are as follows:

All of the NEWANN and SEWAN, of Section 1, Township his, Range 31, lying Northerly and Westerly of the Easterly and/or Scatherly right-of-way for T.H. No. 371 except the part of said NEWANN lying Westerly of the Westerly right-of-way for said highest which lies South of the North 520 feet thereof and which lies East of the West five (5) acres of said NEWANN, and,

All that part of the Jouth 335 feet of the SEguid and the OffsEd, Section 36, Township 45, Rugo 31, which lies Westerly of the Ensterly right-of-way for the Darlington Borthorn Relived right-of-way and which lies Easterly of the Menterly right-of-way line for the T. E. No. 371, Grew Wing County, Minnesots.

2. The Municipal Commission may fested an order immediately amounts the above described realty to the City of Brainard with the cameption of the following described property:

That part of the South 26h feet of the Sits of the Sits and the Sits of the Sits of Seation 36, Summakip h5 North, Range 31 West of the Fourth Principal Maridian in Crow Wing County, Minnesota, described as follows: Commencing at the Sit corner of Brickson Addition to the City of Breiserd according to the plat thereof on file in the office of the Caunty Recorder for said county, said point being at the intersection of the South Line of Bright Street and the Easterly right-of-way line for State Mighway Musber 37; thence South C degrees OI minute 11 seconds West, assumed beering, 17hj. Il feet along said highway right-of-way line, and said right-of-way line extended to the Boyth Line of said "South 28h feet"; thence East 200 feet along said North Line of said "South 28h feet to the South line of said Section 36; thence East along said South line to the South line of said Section 36; thence East along said South line to the Boyth Line of South Section Relived them to Section 16; thence East along said South Line to a point of beginning, thence West 375 feet, more or less to the point of beginning, subject to the right-of-way for the count highway across the Southerly parties of said tract.

as to the realty described in the exception, the City of Brainard is entherised to assess said realty by ordinance without notice to the Township of Grow Wing one year from the date of this Resolution.

In consideration of the foregoing, the City of Brainard agrees to pay to the Township of Grow Wing the advalores taxes levied on the assessed property payable in 1978, an assess equal to the total taxable levied by the township on such property in 1976, payable in 1977.

Said payments shall be made for a period of five years — 100 percent in 1978; 80 percent in 1979, 60 percent in 1980, h0 percent in 1981 and 20 percent in 1982. The city agrees to make such payments within thirty days of receipt of the taxes attributable to the assessed

property on a quarterly basis.

- 5. As to the property described in Paregraph 3, the City of Brainard agreed to pay to the Township of Gray Wing the ad valores taxes levied on said property payable in 1979, 80 percent of the total taxes levied by the Township on such property is 1976, payable in 1977. Said payments shall be made for a period of four years, that is - 80 percent in 1979, 60 percent in 1980, 40 percent in 1981 and 20 percent in 1982. The City agrees to make such payments within 30 days of receipt of the taxes attributable to the said property on a quarterly basis of each stated year.
- 6. That the ad valores bases levied by the Township in 1976, payable in 1977, are the property of and chall be paid to the Township of Green Wings.
- 7. That the City of Breinerd will incur increased costs for services to the Eurered creas and, therefore, it is agreed between the parties hereco that the Minnesota Manicipal Commission may include in its Order for Annexation, without further bearing, an increase of the Leviable annexation the City of Breinerd over and above its present lovy limitations for five years in amounts as follows:
