AN ORDINANCE OF THE CITY OF NORTH MANKATO, MINNESOTA  
DECLARING CERTAIN LAND TO BE ANNEXED TO SUCH CITY, IDENTIFIED AS  
SAUCIER ADDITION.

THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA  
ORDAINS:

Section 1. The following tract of unincorporated property  
abuts upon the municipal limits of the City of North Mankato,  
Minnesota.

Section 2. The legal description of said land is shown upon  
Exhibit A, attached hereto and the same is incorporated herein by  
reference.

Section 3. Such land is now or is about to become urban or  
suburban in character.

Section 4. Such land is unplatted but does not exceed 200  
acres.

Section 5. The sole property owner has petitioned the North  
Mankato City Council to have such land included within such  
city's municipal limits.

Section 6. Such land is hereby annexed to the City of North  
Mankato, Minnesota and is declared to be included within its  
municipal limits.

Section 7. After adoption, signing and attestation, this  
ordinance shall be published once in the official newspaper of  
the City and shall be in effect on and after the day following  
such publication and the date this ordinance is approved by the  
Municipal Board of the State of Minnesota.

## EXHIBIT "A"

OCT 28 1983PARCEL ONE:

The Southwest Quarter of the Northwest Quarter (SW 1/4 of NW 1/4), and all that tract of land located and situated North and West of the Creek in Government Lot Nine (9), all in Section One (1), Township One Hundred Eight (108) North, Range Twenty-seven (27) West, excepting the three following described parcels of land, to-wit:

1. Beginning at the Northeast corner of the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of Section One (1) in Township One Hundred Eight (108) North of Range Twenty-seven (27) West, thence Southerly at a ninety (90) degree angle along the Easterly line of the said Southwest Quarter a distance of three hundred (300) feet; thence Westerly at a ninety degree angle a distance of four hundred twenty (420) feet; thence Northerly at a ninety degree angle three hundred (300) feet; thence Easterly at a ninety degree angle and along the Northerly line of said Southwest Quarter a distance of four hundred twenty (420) feet to the place of beginning.
2. All that part of the following described tract: That part of Government Lot Nine (9) of Section One (1), Township One Hundred Eight (108) North, Range Twenty-seven (27) West, lying North and West of the creek as described in the deed found at "71" of Deeds, page 415; which lies Southeasterly of a line run parallel with and distance three hundred (300) feet Northwesterly of the following described line: Beginning at a point on the North and South Quarter line of Section 2, Township 108 North, Range 27 West, a distance 100 feet North of the South Quarter corner thereof; thence run Easterly at an angle of 89 degrees 07 minutes 10 seconds from said North and South Quarter line (measured from North to East) for 298.01 feet; thence deflect to the left on a 1 degree 30 minute curve (delta angle 63 degrees 28 minutes 34 seconds) for 4231.74 feet; thence on tangent to said curve for 768.09 feet and there terminating; together with all that part of the above described tract adjoining and Northwesterly of the above described strip, which lies Southeasterly of the following described line: From a point on the above described line distant 700 feet Southwesterly of its point of termination, run Northwesterly at right angles to said line for 300 feet to the point of beginning of the line to be described: thence run Southwesterly to a point distant 400 feet Northwesterly (measured at right angles) of a point on Line A described below distant 303.55 feet Southwesterly of its point of termination; thence run Southwesterly parallel with said Line A for 1100 feet and there terminating; Line A. From a point on the above described line 268.35 feet Easterly of its point of beginning, run Northerly at right angles to said line for 90 feet to the point of beginning of the line to be described; thence deflect to the right at an angle 90 degrees 00 minutes for 108.32 feet; thence deflect to the left on a 1 degree 33 minute curve (delta angle 63 degrees 28 minutes 34 seconds) for 4095.23 feet and there

terminating, containing 11.94 acres, more or less; together with all right of access being the right of ingress to and egress from all that part of the above described tract not acquired herein to Trunk Highway No. 14.

3. Commencing at the Northwest corner of the Southwest Quarter of the Northwest Quarter of Section One (1), Township One Hundred Eight (108) North, Range Twenty-seven (27) west; thence North 88 degrees 24 minutes 55 seconds East, along the North line of the Southwest Quarter of the Northwest Quarter of said Section 1, a distance of 367.81 feet; thence South 00 degrees 01 minutes 35 seconds West, parallel with the West line of the Southwest Quarter of the Northwest Quarter of Section 1, a distance of 592.15 feet; thence South 88 degrees 24 minutes 55 seconds West, parallel with the North line of the Southwest Quarter of the Northwest Quarter of said Section 1, a distance of 367.81 feet; thence North 00 degrees 01 minutes 35 seconds East, along the West line of the Southwest Quarter of the Northwest Quarter of said Section 1, a distance of 592.15 feet to the point of beginning. Said tract containing 5.0 acres, more or less, all in Nicollet County, Minnesota.

PARCEL TWO:

The Southeast Quarter of the Northeast Quarter (SE 1/4 of NE 1/4) of Section Two (2), Township One Hundred Eight (108) North, Range Twenty-seven (27) West.

EXCEPTING: Valley View Subdivision, located in the NW 1/4 of SW 1/4 of Section 1 and the SE 1/4 of Section 2, Township 108 North, Range 27 West, City of North Mankato.

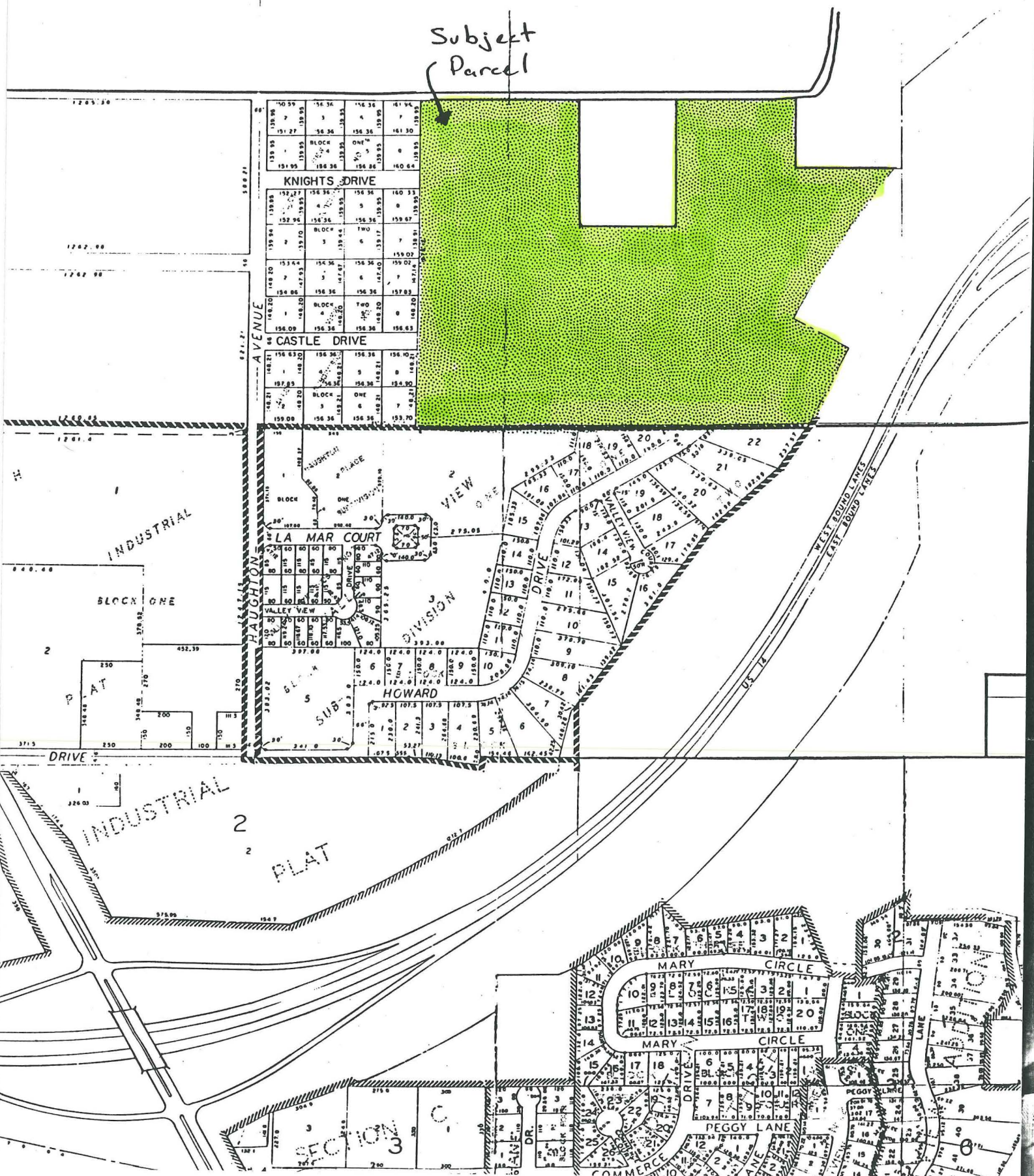

Also Excepting: South Half of Southeast Quarter of Southeast Quarter of Northeast Quarter in Section 2, Township 108 North, Range 27 West.
