That part of the Southwest Quarter (SW2) of Section Thirty-five (35), Tourship One Hundred Seven (107) North, of Range Seven (7), West of the Fifth Principal Meridian, Winona County, Minnesota, described as follows:

Beginning at a point where the South line of Trunk Highway No. 43 intersects the West line of said Section 35 for the place of beginning of the land herein described; thence South along the West line of said Section 35, 1054 feet to the Southwest corner of said Section 35; thence East along the South line of said Section 35 on an assumed bearing of North 88° 41' East a distance of 1023 feet; thence North 62° 38' East a distance of 63.53 feet; thence North 55° 14' East a distance of 76.20 feet; thence North 81° 00' East a distance of 195.17 feet; thence Northerly along a line drawn to a point in the center of the West Burns Valley Road, which point is 19.83 chains distant from the West line of said Section 35 (measured along the center line of said road) to the point where said last described line intersects the Southerly right-of-way line of Trunk Highway No. 43; thence Southwesterly along said Southerly right-of-way line of Trunk Highway No. 43 to the place of beginning; excepting therefrom the following described three parcels of land.

thence continuing Easterly on said curve a distance of 125.10 feet to a point; thence Southerly at right angles from a line between the point of beginning and the last described point a distance of 125.0 feet; thence Westerly at right angles a distance of 125.0 feet; thence Northerly to the actual point of beginning. The above described parcel containing 0.35 acres.

Commencing at a point where the Southerly line of the right-of-way of Minnesota Trunk Highway No. 43 intersects the West line of said Section 35; thence Northerly along the West line of said Section 35 a distance of 50 feet more or less to the conter line of said Minnesota Trunk Highway No. 43; thence deflect to the right 73° 56'; for a distance of 538.10 feet; thence deflect to the right 1° 28' 30" for a "chord distance" of 406.35 feet; thence deflect to the right 90° 19' for a distance of 187.25 feet; thence deflect to the right 36° 39' for a distance of 455.60 feet; thence deflect to the left 11° 18' for a distance of 143.66 feet to the point of beginning of the lend herein described;

thence deflect to the right 40° 23' 30" for a distance of 256.10 feet; thence deflect to the left 79° 0?' for a distance of 452.80 feet; thence deflect to the left 62° 26' for a distance of 322.72 feet; thence deflect to the left 55° 09' for a distance of 76.20 Ceet; thence deflect to the right 25° 46' for a distance of 195.17 feet to a point; thence deflect to the left 84° 43', more or less, a distance of 279.20 feet along a line drawn from said last mentioned point to a point in the center of the West Burns Valley Road, which point is 19.88 chains distant from the West line of said Section 35 (measured along the center line of said read); thence deflect to the left 51° 19' for a distance of 500.40 feet; thence deflect to the left 60° 51' for a distance of 172.80 feet to the point of beginning.

Also, for the express purpose of ingress to and egress from the above tract of land, an easement for use as a road over and across that part of the Southwest Quarter  $(SW_{u}^{1})$  of said Section Thirty-five (35), which lies within a distance of 16.5 feet on each side of the following described center line:

Commencing at a point where the Southerly line of the right-of-way of Minnesota Trunk Highway No. 43 intersects the West line of said Section 35; thence Northerly along the Mest line of said Section 35 a distance of 50 feet, more or less, to the center line of said Minnesota Trunk Highway No. 43; thence deflect to the right 73° 56' for a distance of 538.10 feet; thence deflect to the right 1° 28' 30" for a "chord distance" of 406.35 feet; thence deflect to the right 90° 19' for a distance of 50.00 feet to the South rightof-way limits of Minnesota Trunk Highway No. 43, which is the point of beginning; thence continue in a Southeasterly direction along the last described course for a distance of 125.00 feet; thence deflect to the right along 154° 54' curve (Delta angle 36° 39', radius 26.99 feet) for an "Arc distance" of 23.66 feet; thence on tangent to said curve for a distance of 393.35 feet; thence deflect to the left on a 11° 20' 24" curve (delta engle 1° 18', radius 505.41 feet) for an "Arc distance" of 99.65 feet; thence on a tangent to said curve for a distance of 120.00 feet to a point "within" the limits of the first above described parcel of land, and there terminating.
