## APPROVING THE PETITION OF THE CITY OF FARIBAULT, MINNESOTA TO ANNEX CERTAIN ADJOINING UNINCORPORATED TERRITORY TO THE CITY

WHEREAS, certain property described in Exhibit A, attached, presently unincorporated and adjacent to the City of Faribault, Minnesota, and:

WHEREAS, this territory abuts upon the city limits at the southeasterly corner of the corporate boundaries of the City of Faribault, and;

WHEREAS, portions of the territory are currently under the ownership of the City of Faribault, Minnesota, and;

WHEREAS, the territory described herein is or is about to become urban or suburban in character.

NOW, THEREFORE, BE IT RESOLVED:

Section 1. The City of Faribault petitions the State of Minnesota municipal board for the annexation of certain unincorporated territory, described in Exhibit A, attached, to the corporate limits of the City of Faribault, Minnesota.

Section 2. The City Council hereby further determines that:

- (a) the proposed unincorporated territory does not contain a permanent residential population,
- (b) the property is currently described as parkland and a nature conservatory,
- (c) the annexation will be in the best interest of the City and the surrounding territory in an effort to continue cost effective service delivery,
- (d) the territory described therein is presently being provided governmental services by the petitioning municipality,
- (e) the annexation will have minimal effect fiscal effect on Rice County, the school district, and the townships,
- (f) the territory described below abuts the corporate limits and is about to become urban and suburban in character,
- (g) a portion of the territory described herein is currently under the ownership of the City of Faribault
- (h) the majority of the territory described herein is currently leased to the City of Faribault on a long term basis,

 (i) annexation of the property to the corporate limits will provide that the total River Bend Nature Center property will be within the corporate limits.

Section 3. The City Administrator is hereby directed and empowered to file a copy of said petition with the State of Minnesota Municipal Board together with the prescribed documents and fees thereto.
