

ORDINANCE NO: 283

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLEEPY EYE TO INCLUDE CERTAIN UNPLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS, a Petition dated February 5, 1985, requesting annexation of territory for unplatted land located in Home Township was presented to the Council,

WHEREAS, the territory described abuts upon the City limits and it is determined by the Council that the property is presently or is about to become urban or suburban in character;

The City of Sleepy Eye does therefor ordain as follows:

SECTION 1. The City Council hereby determines that the annexation will be to the best interests of the City and of the territory affected, that the territory described herein abuts upon the City limits and is urban or suburban in character, and that none of the territory is now included in the limits of any City and does not abut upon the limits of any other City.

SECTION 2. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Commencing at the Southeast corner of Block 1, Nursing Home Addition, City of Sleepy Eye, thence 80 feet East, thence 65 feet South to the point of beginning; thence due East 331.00 feet, thence due North 515 ft; thence due West 331.00 feet; thence due South 515.00 feet to the point of beginning containing 3.91 acres, more or less.




