## IN THE MATTER OF THE PETITION OF CERTAIN PERSONS FOR ANNEXATION TO THE CITY OF WINDOM, COTTONWOOD COUNTY, MINNESOTA

The undersigned Petitioners hereby represent and show to the City Council of the City of Windom, Cottonwood County, Minnesota:

1. That your Petitioners hereby petition the City Council of the City of Windom, Minnesota, to annex to said city the following described premises abutting said city:

All that part of the Southwest Quarter of the Northeast Quarter and of the Northwest Quarter of the Southeast Quarter of Section 22, Township 105, Range 36 bounded by the following described lines:

On the West side by the West line of the Southwest Quarter of the Northeast Quarter and the Northwest Quarter of the Southeast Quarter in Section 22, Township 105, Range 36.

On the Northeasterly side by the center line of County State Aid Highway No. 13.

On the Southeasterly side by the following described line:

Beginning at a point on the center line of County State Aid Highway No. 13 which is 50.3 feet Southeasterly of the intersection of said center line with the East-West Quarter line of said Section 22, said point being the most Easterly point of tract conveyed by deed recorded in File 162, Card 572 (Austin); thence running

- (1) Southwesterly at right angles to said center line a distance of 167.7 feet; thence running
- (2) Northwesterly and parallel with said center line a distance of 100 feet to the most Easterly point of tract conveyed by deed recorded in File 162, Card 601 (Smith); thence running

(3) Southwesterly on and along the Southeasterly line of the tract conveyed by the deed last described and on and along the Southeasterly line of the tracts conveyed by deeds recorded in File 151, Card 482 (Amundson) and in Book 89 of Deeds, Page 429 (Koens), a distance of 201.3 feet to the most Southerly point of the tract conveyed by the deed last described; thence running

- (4) Northwesterly a distance of 24 feet to the most Easterly point of tract conveyed by deed recorded in Book 93 of Deeds, Page 373 (Moe); thence running
- (5) Southwesterly on and along the Southeasterly line of the tract conveyed by the deed last described a distance of 220 feet more or less to the point of intersection with the center line of the Des Moines River; thence running
- (6) Westerly on and along the center line of the Des Moines River to the point of intersection with the West line of the Northwest Quarter of the Southeast Quarter of Section 22, Township 105, Range 36.

Excepting therefrom the following described tract:

Beginning at a point on the center line of County State Aid Highway No. 13 which is 306.7 feet Northwesterly of the point of intersection of said center line and the South line of Southwest Quarter of the Northeast Quarter of Section 22, Township 105, Range 36, being the most Easterly point of the tract conveyed in Book 90 of Deeds, Page 390 (Hulsing); thence running

- (1) Southwesterly at right angles to said center line a distance of 444 feet more or less to the West line of the Northwest Quarter of the Southeast Quarter of Section 22, Township 105, Range 36, said line being designated as Line "A"; thence
- (2) retracing Line "A" to the point of beginning; thence running
- (3) Northwesterly on and along the center line of County State Aid Highway No. 13 a distance of 80 feet; thence running
- (4) Southwesterly at right angles to said center line a distance of 375 feet to the

West line of the Southwest Quarter of the Northeast Quarter of Section 22, Township 105, Range 36; thence running

- (5) South on and along the North-South Quarter line to the point of intersection with Line "A"; thence running
- (6) Northeasterly on and along Line "A" to the point of beginning.

2. That attached hereto, marked Exhibit "A" and made a part hereof, is a map showing the area above described and proposed for annexation.

3. That your Petitioners are all of the freeholders in the property above described and proposed for annexation.

4. That there are approximately 5.30 acres of land in the area proposed for annexation.

5. That there are 28 residents in the area proposed for annexation.

6. That there are 10 single family detached dwellings with accessory structures in the area proposed for annexation.

7. That the area proposed for annexation is not presently served by public water and sewer, but that the City of Windom has indicated that it will serve said property with water and sewer in the event that it is annexed. That the area is subject to Cottonwood County Zoning regulations. That there is no police protection in said area. That Great Bend Township presently furnishes fire protection for said area under a contract with the City of Windom. That County State Aid Highway No. 13 , also known as River Road,

together with a township cartway are the public highways servicing said area.

8. That said area is urban in character and is so conditioned as to be properly subject to municipal government.

9. That said area abuts Kountry Acres Subdivision No. 2, an addition to the City of Windom, and an unplatted area of the City of Windom on its Northeast side.
