WHEREAS, the City Council of the City of Olivia has received a petition for annexation for the:


South 20 rods, except the South 50 feet thereof of the Southeast Quarter of the Northeast Quarter, Section 13, Township 115, Range 35; and



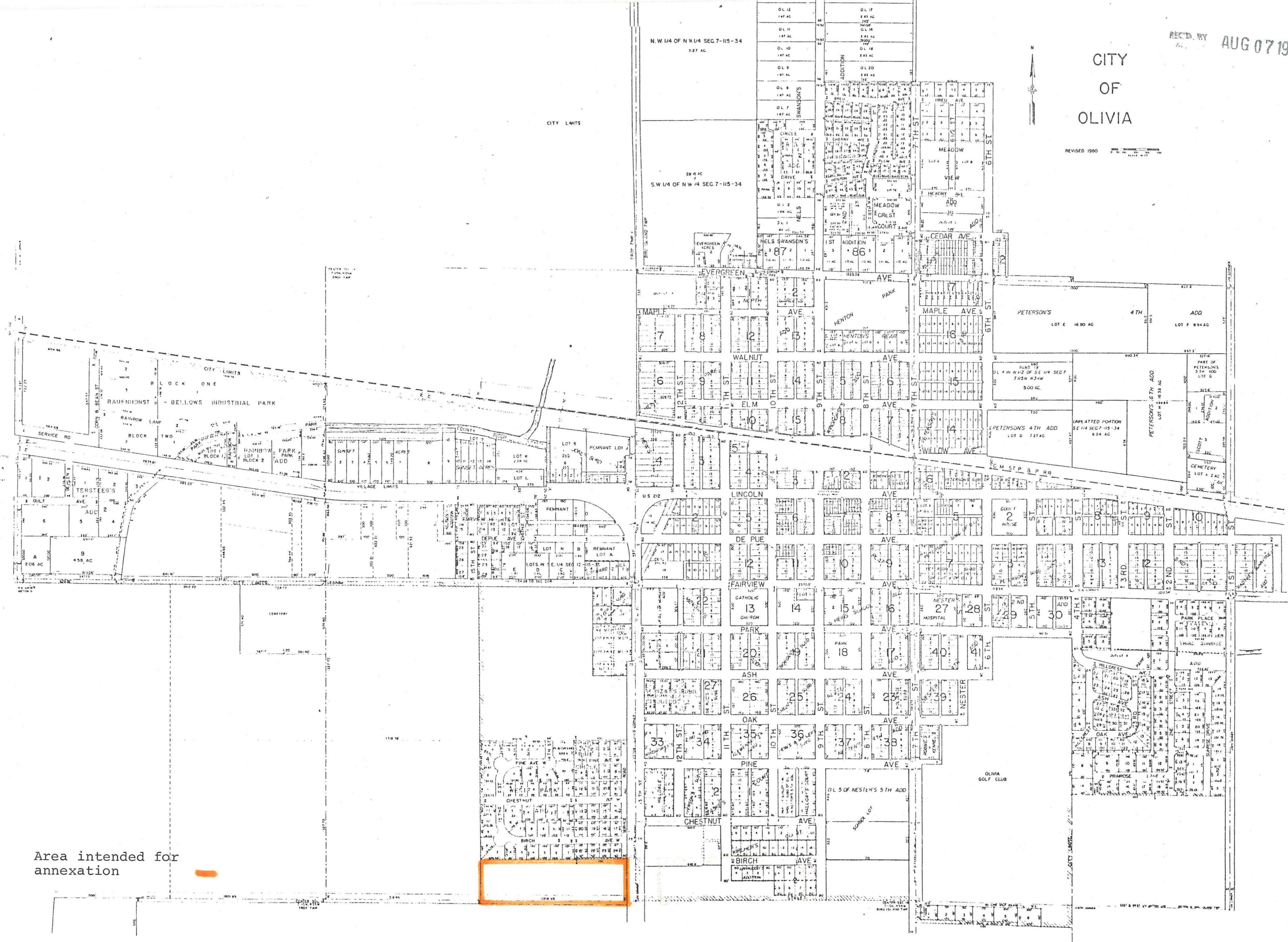
