PETITIONERS REQUEST: That pursuant to M.S. 414.033, said property be annexed to and included within the City of Willmar.



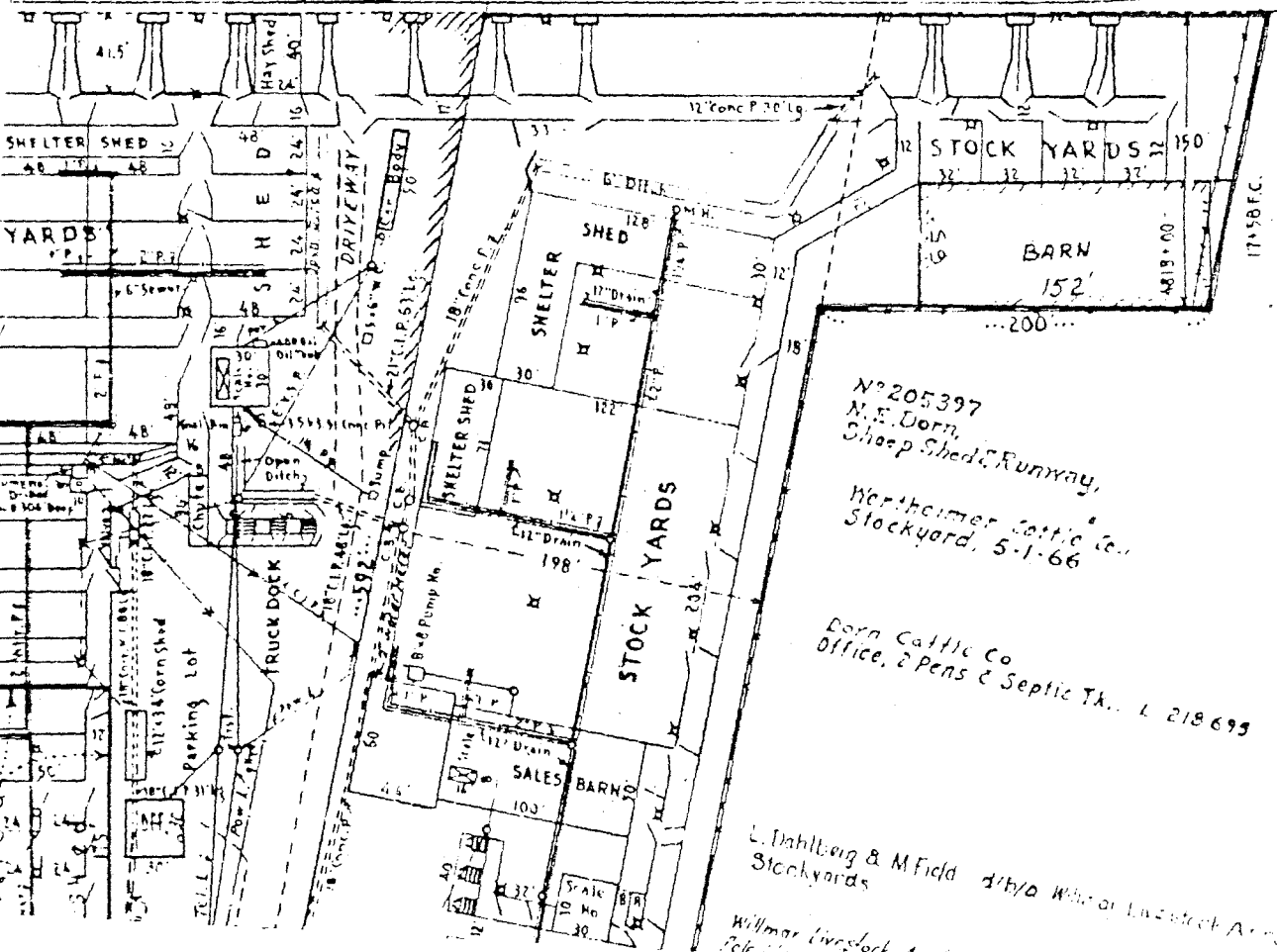

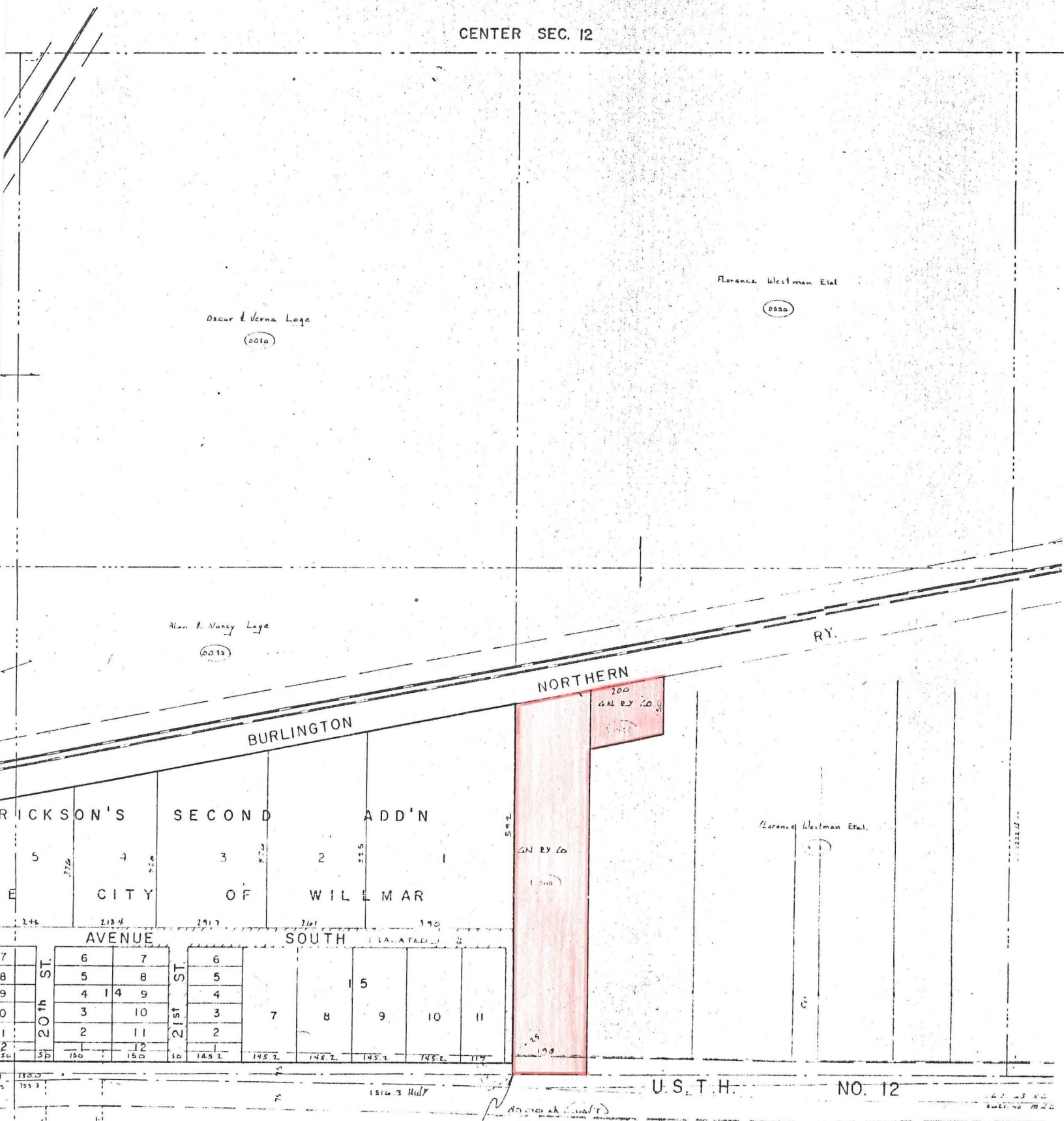
WHEREAS, the said real estate to be annexed is described as follows, to-wit:
