ORDINANCE NO: 290

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLEEPY EYE TO INCLUDE CERTAIN PLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS, a Petition dated October 10, 1985, requesting annexation of territory for platted land located in Home Township was presented to the Council, and

WHEREAS, the territory described abuts upon the City limits and it is determined by the Council that the property is presently urban or suburban in character;

The City of Sleepy Eye does hereby ordain as follows:

SECTION 1. The City Council hereby determines that the annexation will be in the best interest of the City and of the territory affected, that the territory described herein abuts upon the City limits and is urban or suburban in character, and that none of the territory is now included in the limits of any City and does not abut upon the limits of any other City.

SECTION 2. The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part hereof:

Lot 7 of the E $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Section 31,
Township 110N, Range 32W, Brown County,
Minnesota.
