TO: The City Council of the City of Glencoe and the Minnesota Municipal Board

We, the undersigned, constituting 100% of the owners of the territory described below, hereto request and petition that said lands be annexed to the City of Glencoe and that the City of Glencoe boundaries be extended to include the same, and for that purpose respectfully state:

1. That the territory to be annexed consists entirely of lands unplatted approximately amounting to 30 acres lying exclusively in Glencoe Township, McLeod County, Minnesota, and described as follows, to-wit:

That part of the Northeast Quarter of the Northeast Quarter of Section 23, Township 115, Range 28, McLeod County, Minnesota, lying East of the centerline of Buffalo Creek; and also all that part of Tract C, registered land survey No. 4, files of the Registrar of Titles, McLeod County, Minnesota, lying East of the centerline of Buffalo Creek.

That said lands abut the westerly boundary line of the present corporate limits of the City of Glencoe.

2. The following parties are entitled to notice to these proceedings pursuant to Minnesota Statutes Section 414.09: The County of McLeod; Helen Township; the City of Glencoe; and the McLeod County Zoning Board.

3. That the reason for the requested annexation is that the property is urban in character and requires municipal services to be provided by the City of Glencoe, particularly municipal water, which this requested annexation will permit.
