The W. 297.16' of the SE $\frac{1}{4}$  of Section 22, Township 119, Range 35 exc. the N. 1,676.20' thereof.

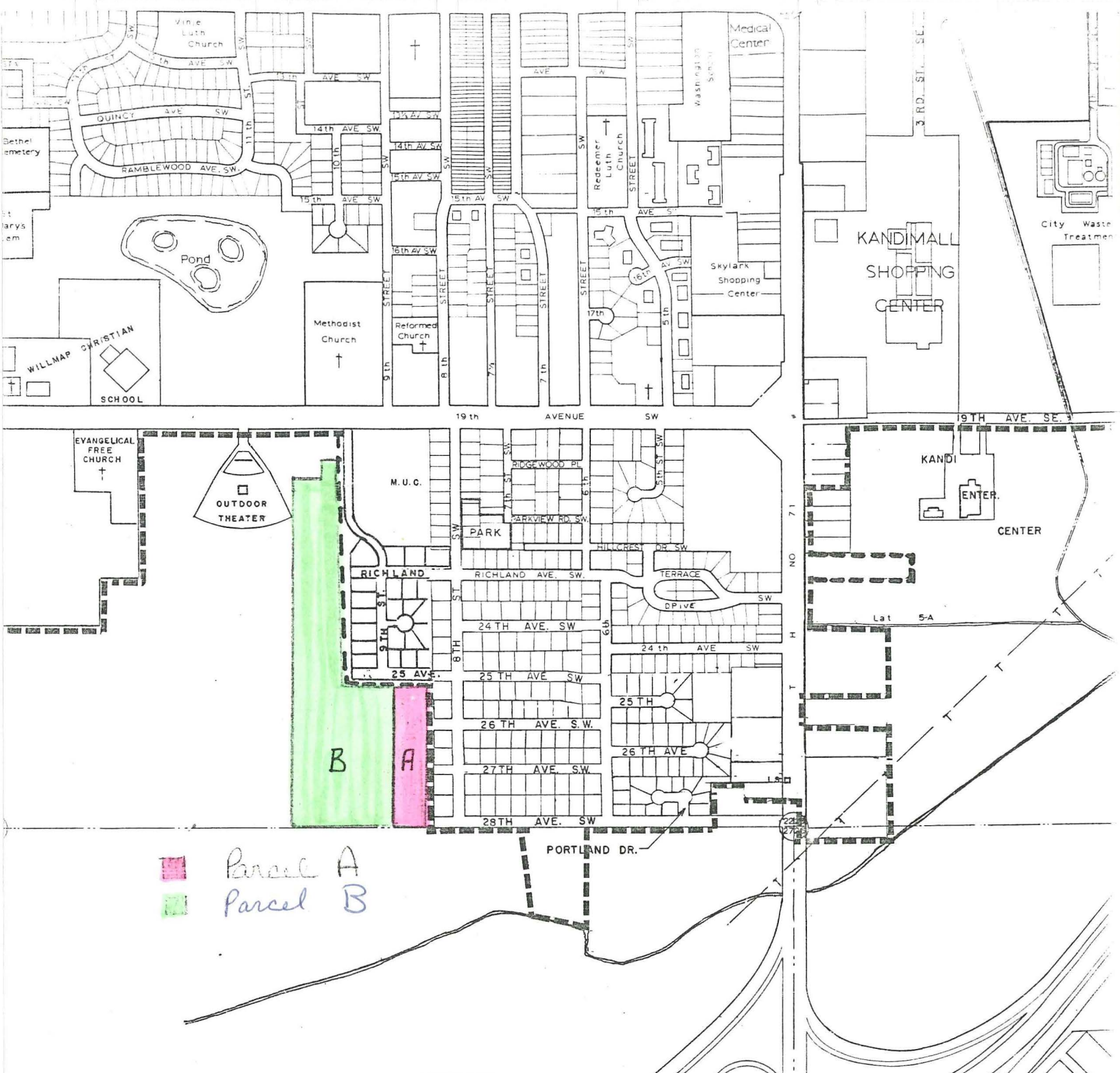
