

Petition by Independent School District #720 in the City of Shakopee,
County of Scott and State of Minnesota for Annexation of Certain Real
Property By the City of Shakopee

The Petitioner, Independent School District #720, located in the City of Shakopee,
County of Scott and State of Minnesota for its petition for annexation proceedings
pursuant to Minnesota Statutes 414.033 Subd. 5, states and petitions and follows:

1. That Independent School District #720 is located in the City of Shakopee,
County of Scott and State of Minnesota.

2. That it is the fee owner of the following described property located
in the City of Shakopee, County of Scott and State of Minnesota:

That part of the South Half of the Northesat Quarter of Section
12, Township 115, Range 23, described as follows: Beginning at
the southeast corner of Jasper and Smith Addition to Shakopee,
according to the plat thereof on file and of record in the office
of the Scott County Recorder; thence South on the extended east
line of said Addition 382.2 feet; thence East parallel with the
South line of Tenth Avenue 1416.3 feet to the east line of said
South Half; thence North along said east line 232.95 feet to the
northeast corner of said South Half; thence Westerly along the
north line of said South Half 1424.9 feet more or less to the
point of beginning.

3. That the above described real estate is solely owned by the Petitioner free
from encumbrances and abuts property owned by the Petitioner and abuts the City of
Shakopee. The property is unplatted and contains less than 200 acres.

4. That the Petitioner requests, pursuant to Minnesota Statutes 414.033,
Subd. 5, that the City of Shakopee annex the above described property into its
municipal boundary, which property is uninhabited.

5. That the Petitioner has within ten days from the date of this Petition
filed this Petition with the Scott County Board of Commissioners, the Jackson Town
Board and the Minnesota Municipal Commission.
