PETITION FOR ANNEXATION

TO: THE CITY COUNCIL OF THE CITY OF SAINT PETER, MINNESOTA

We the undersigned, being owners of land described herein, do hereby Petition the City Council to annex this land to the City and to extend the City boundaries to include the same, and do hereby state:

1. Petitioners are the sole owners of the land described of herein, the subject of this Petition for Annexation.
2. This land abutts the City.
3. This land is unplatted and does not exceed 200 acres.
4. The description of the land, the subject of this Petition is as follows, to-wit:

That part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Seventeen (17), Township One Hundred Ten (110) North of Range Twenty-six (26) West, described as follows: Commencing at the Southeast corner of Section Seventeen (17), thence north along the east line of Section Seventeen (17), a distance of 691.0 feet; thence west and parallel to the south line of Section Seventeen (17) a distance of 752.7 feet to the point of beginning; thence south and parallel to the east line of Section Seventeen (17) a distance of 407.52 feet to the centerline of S.A.R. Five (5); thence deflecting right sixty (60) dgrees 41 minutes along the centerline of S.A.R. Five (5) a distance of 114.68 feet; thence deflecting right 119 degrees 19 minutes and parallel to the east line of Section Seventeen (17), a distance of 463.68 feet; thence deflecting right ninety (90) degrees 00 minutes a distance of 100.00 feet to the point of beginning, said tract containing 1.0 acres of land, more or less. The southerly 40.00 feet of this tract being subject to the use of the public highway right of way.

5. This tract contains approximately 1 acre of land, more or less.
6. Petitioners state that the property proposed for annexation is now, or is about to become, urban in character.

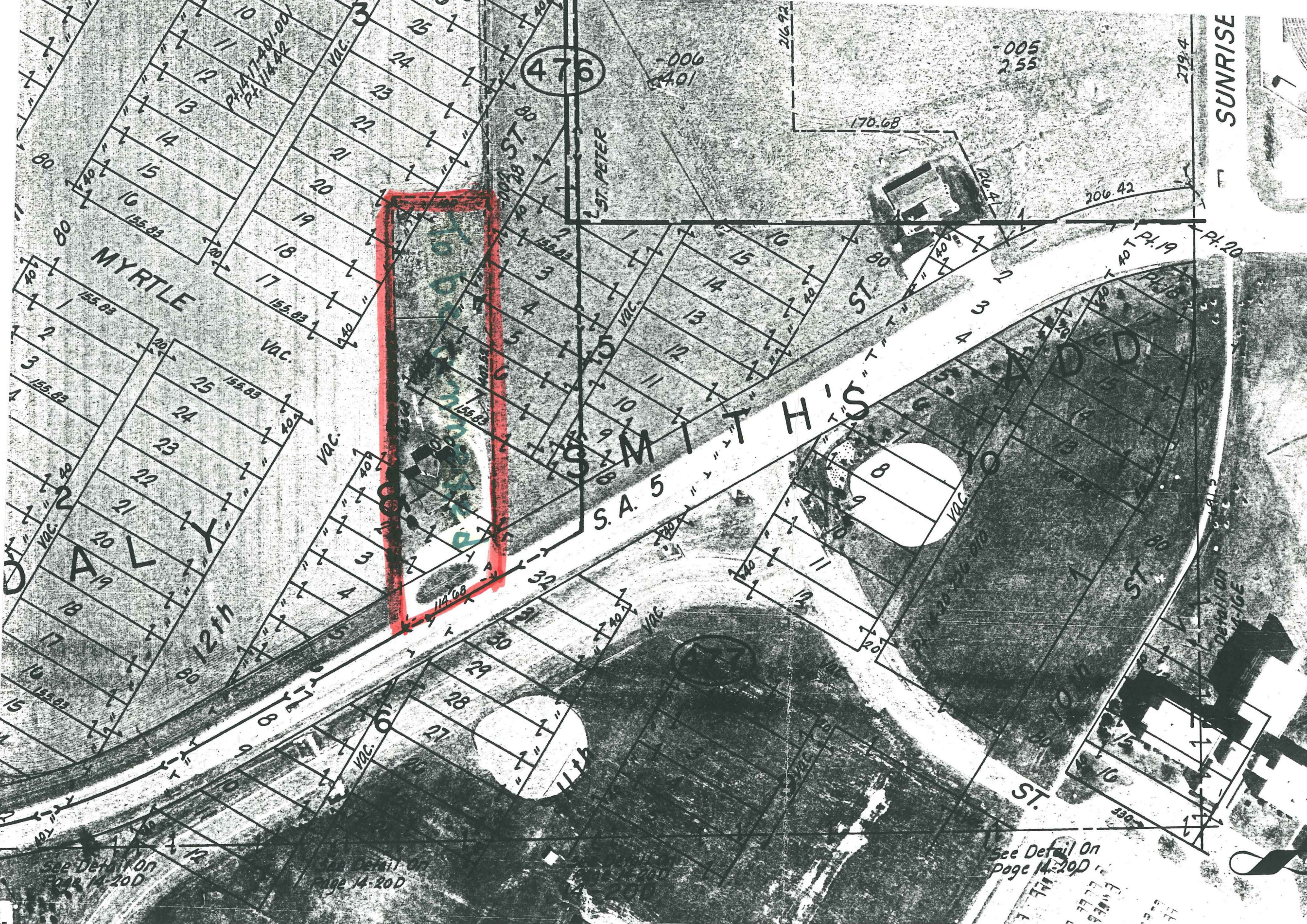
