PETITION FOR ANNEXATION

TO THE COUNCIL OF THE CITY OF BRAHAM, MINNESOTA:

THE UNDERSIGNED, being all of the owners of the territory hereinafter described, hereby request and respectfully Petition the City Council of Braham, Minnesota to Annex this territory to the City of Braham and to extend the City boundaries to include the same, and for that purpose respectfully state:

1. That the territory to be annexed consists wholly of land which does not exceed 200 acres in area. Said lands are unplatted. That all of said lands lie entirely within and Township of Stanchfield, in the County of Isanti, and State of Minnesota, and the description of said lands is as follows, to-wit:

The above-described parcel consists of approximately 12.3 acres.

- 2. That the territory described above abutts upon the City of Braham limits in part, and none of it is presently a part of an incorporated City, Village or Borough.
- 3. That all of said territory is so conditioned as properly to be subjected to municipal government, and the undersigned believe that it would be in the best interest of the undersigned and in the best interest of the City of Braham if said territory were included in

the City of Braham and annexed thereto. That City sewer and water are available in the vicinity and such extension is feasible and appropriate.

- 4. That there are two persons residing in the area at this time; that the lands contain the house of worship of the Petitioner.
- 5. That the names of the parties entitled to notice hereunder are: City of Braham, Township of Stanchfield, County of Isanti and the Minnesota Municipal Board.
- 6. That the territory is, or is about to become, urban or suburban in character.

WHEREFORE, the undersigned respectfully petitions the City Council of Braham to include the land heretofore described which is requested to be annexed within the boundaries of the City of Braham, Minnesota, and to annex said territory in accordance with Minnesota Statutes, Chapter 414, as amended, or such other statutes in such cases are made and provided.
