PETITION FOR ANNEXATION

TO THE CITY OF BROWNTON, McLEOD COUNTY, MINNESOTA:

I.

The undersigned petitioners are the owners and do request and desire that certain lands be annexed to the City of Brownton, McLeod County, Minnesota, and be included within the corporate limits of the City of Brownton, said lands being described as:

That part of Government Lot 1 of Section 31 in Township 115 North of Range 29 being 448 feet South of the section corner of Section 29, 30, 31, and 32 in said Township and Range; thence West 100 feet; thence South 15 feet; thence East 100 feet; thence North 15 feet to the point of beginning.

II.

The said lands described in the preceeding paragraph abut the present corporate limits of the City of Brownton. The lands are unplatted and are less than one acre in size. The said lands are not now included in any other municipality.

III.

No petition for annexation of any part of said lands is presently before the commission.

IV.

The undersigned petitioners constitute all of the landowners and parties having an interest in said lands.

V.

The undersigned petitioners believe that the said lands are now or are about to become urban or suburban in character and that the annexation of said lands to the City of Brownton would be in the best interest of the City of Brownton.

VI.

That this petition is brought pursuant to Minnesota Statutes, Section 414.033, subd. 3.— ? sb 5

VII.

WHEREFORE, petitioners pray:

I.

That said annexation be approved by the authorities prescribed by law and that the City of Brownton annex said premises by ordinance as provided by law.




