Beginning at the southeast corner of said Government Lot Three; thence on an assumed bearing of North 0 degrees 01 minutes 19 seconds West on and along the east line of said Government Lot Three a distance of 532.43 feet to its intersection with the westerly right of way of STATE HIGHWAY PLAT NO. 84-4; thence on and along said right of way line on a curve that is concave to the east, said
