PETITION FOR ANNEXATION

TO: THE HONORABLE CITY COUNCIL OF THE CITY OF WATERTOWN, MINNESOTA:

The undersigned Petitioners hereby respectfully request and state to the City Council of the City of Watertown as follows:

1. That they are all of the property owners of the land hereinafter described and that they make this Petition pursuant to Minnesota Statutes Section 414.033, Subd. 5.
2. That they desire and request that certain land be annexed to the City of Watertown, Carver County, Minnesota, and included within the corporate limits of the City of Watertown, including all streets, roads or highways passing through or adjacent to said lands as shown on the map of said lands attached hereto and made a part hereof. Said land being legally described as follows:

Outlots 20, 21, 22, 24, and 25, except the South 209 feet of the East 232.69 feet of said Outlot 25, Village of Watertown, also known as Town or Townsite of Watertown, according to the plat thereof on file and of record in the office of the County Recorder, Carver County, Minnesota.
3. That said land abuts the present corporate limits of the City of Watertown; that said land is ~~not~~ platted; and that said land is not now included within any municipality, nor does said land boarder any other municipality.
4. That said land contains approximately 9 acres including streets and highways.
5. That your Petitioners believe that said land is conditioned as properly to be subject to municipal government and that said annexation would be in the best interests of the City of Watertown and of the land proposed to be annexed.
6. That the undersigned Petitioners make this Petition to the Honorable City Council of the City of Watertown, Carver County, Minnesota, in accordance with and pursuant to Minnesota Statutes Section 414.033, Subd. 5, and pray that the City Council will accept this Petition and take all action necessary for annexation of the above described land under the authority granted by said statute.




