TO THE COUNCIL OF THE CITY OF BRAHAM, MINNESOTA:

We, the undersigned, all (a majority of) the owners of the territory described below, hereby request the council to annex this territory to the city and to extend the city boundaries to include the same, and for that purpose respectfully state:

1. The territory to be annexed consists entirely of unplatted lands not exceeding 200 acres in area. All of these lands lie entirely within the County of Isanti, Minnesota and the description of such lands is as follows:

That part of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section 11, Township 37, Range 23, described as follows, to-wit: Commencing at the Northwest corner of said Northeast Quarter of Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$), thence South along the West line thereof a distance of 40 rods to the point of beginning of the tract to be herein conveyed; thence East and parallel with the North section line of said Section 11 to the Westerly right of way line of State Trunk Highway #107; thence southwesterly following said right of way line to a point where said boundary line intersects the West line of said Northeast Quarter of Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$); thence North following said West line to the point of beginning and there to terminate. TOGETHER WITH a road easement for the purposes of ingress and egress, said easement being 33 feet in width with the Easterly line thereof being described as follows, to-wit: Commencing at the Northeast corner of the tract being herein conveyed, thence North-easterly along said Westerly right of way line of State Trunk Highway #107 to its intersection with that certain farm entrance established and described in the Final Certificate dated May 25, 1943 and filed for record in the Isanti County Recorder's Office in Book "M" of Misc. page 175 on June 24, 1943, and as set forth in the Right of Way Map of State Project 3004 (107=5) Parcel 10, on file and of record in the Isanti County Recorder's Office.
