## PETITION FOR ANNEXATION

TO THE COUNCIL OF THE CITY OF CAMBRIDGE, MINNESOTA:

THE UNDERSIGNED, being all of the owners of the territory hereinafter described, hereby request and respectfully petition the City Council of Cambridge, Minnesota to annex this territory to the City of Cambridge and to extend the City boundaries to include the same, and for that purpose respectfully state:

1. That the territory to be annexed consists wholly of land which does not exceed 200 acres in area. Said lands are platted. That all of said lands lie entirely within the Township of Isanti, in the County of Isanti, and State of Minnesota, and the description of said lands is as follows, to-wit:

All that part of the Northeast Quarter of the Northwest Quarter, Section 8, Township 35, Range 23, Isanti County, MN, described as follows, to-wit: Commencing at the NE corner of said NEt of NWt; thence West, along the north line thereof, 330 feet (said point being the NE corner of the plat of Woodland Park); thence South 1°25'44" East, along the east line of said plat, 673.01 feet; thence West, along the south line of said plat, 187.5 feet; thence South 1°25'44" East, following the boundary of said plat, 66.02 feet; thence West, along the south line of said plat, 253.5 feet to the point of intersection with the southerly extension of the west line of Lot 4, Block 2 of said plat; said point to be the point of beginning; thence North, along the southerly extension of the west line of said Lot 4, Block 2, and along the west lines of Lots 4, 3, 2, and 1 and the northerly extension of the west line of Lot 1, 739 feet, more or less, to the north line of said  $NE\frac{1}{4}$  of  $NW\frac{1}{4}$ ; thence West along said north line, to the NW corner of said NEt of NWt, thence South 1°14'28" East a distance of 738.97 feet to the SW corner of the plat of Woodland Park; thence East along the South line of said plat of Woodland Park to the point of beginning and there to terminate.

The above described parcel consists of approximately 9.29 acres.

- 2. That the territory described above abutts upon the City of Cambridge limits in part, and none of it is presently a part of an incorporated City, Village or Borough.
- 3. That all of said territory is so conditioned as properly to be subjected to municipal government, and the undersigned believe that it would be in the best interest of the undersigned and in the best interest of the City of Cambridge if said territory were included in the City of Cambridge and annexed thereto. That City sewer and water are available in the vicinity and such extension is feasible and appropriate.
