

THE MATTER OF THE PETITION OF
HAROLD NORBERG AND JUDITH M. NORBERG, HUSBAND AND WIFE

PETITION FOR ANNEXATION

TO THE COUNCIL OF THE CITY OF CAMBRIDGE, MINNESOTA:

THE UNDERSIGNED, being the owners of the territory hereinafter described, hereby request and respectfully petition the City Council of Cambridge, Minnesota to annex this territory to the City of Cambridge and to extend the City boundaries to include the same, and for that purpose respectfully state:

1. That the territory to be annexed consists wholly of land which does not exceed 200 acres in area. Said lands are unplatted. That all of said lands lie entirely within the Township of Isanti, in the County of Isanti, and State of Minnesota, and the description of said lands is as follows, to-wit:

That part of the Northwest One-quarter of the Northwest One-Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$) Section 8, Township 35, North, Range 23, West, Isanti County, Minnesota, described as follows: Beginning at a point on the East line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ distant 820 feet South of the Northeast corner of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$, (said East line bearing South 0°00', assumed), thence South 0°00' along said East line, 100 feet, thence South 68°23' West, 100 feet, thence North 0°00', 100 feet, thence North 68°23' East, 100 feet, to the point of beginning and there to terminate.

AND

That part of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Eight (8), Township Thirty-five (35), Range Twenty-three (23), described by metes and bounds as follows: Commencing at the Southwest corner of said Northeast Quarter of Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$); for a point of beginning; thence East following the South line of the said tract for a distance of 18 feet; thence North and parallel to the West line of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) a distance of 592.21 feet; thence West and parallel to the South Section line a distance of 18 feet to the West line of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$); thence

South following said West line to the point of beginning and there to terminate.

The above described parcel consists of approximately 0.24 acres.

2. That the territory described above abutts upon the City of Cambridge limits in part, and none of it is presently a part of an incorporated City, Village or Borough.

3. That all of said territory is so conditioned as properly to be subjected to municipal government, and the undersigned believe that it would be in the best interest of the undersigned and in the best interest of the City of Cambridge if said territory were included in the City of Cambridge and annexed thereto. That City sewer and water are available in the vicinity and such extension is feasible and appropriate.

4. That there are 4 persons residing in the area at this time, the property being residential in nature.

5. That the names of the parties entitled to notice hereunder are: City of Cambridge, Township of Isanti, County of Isanti and the Minnesota Municipal Board.

6. That the territory is, or is about to become, urban or suburban in character.

WHEREFORE, the undersigned respectfully petitions the City Council of Cambridge to include the land heretofore described which is requested to be annexed within the boundaries of the City of Cambridge, Minnesota, and to annex said territory in accordance with Minnesota Statutes, Chapter 414, as amended, or such other statutes in such cases are made and provided.


