ORDINANCE TO ANNEX CERTAIN PROPERTY ADJOINING

THE CITY OF PAYNESVILLE

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borrough; and,

WHEREAS, this territory borders upon the City limits of the City of Paynesville and is deemed to be urban in the character; and,

WHEREAS, the property has access to City water and sewer and has been developed to some degree and is in a position for further development,

NOW, THEREFORE, the City Council of the City of Paynesville ordains:

SECTION 1. TERRITORY ANNEXED. The corporate limits of the City of Paynesville, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory is now and has heretofore been adjacent to the incorporated limits of the City of Paynesville:

A part of the Southeast Quarter (SE4) of Section Sixteen (16), Township One Hundred Twenty-two (122) North, Range Thirty-two (32) West, described as follows: Beginning at the center of said Section 16; thence along the North line thereof East 50.0 feet to the right of way line of Minn. T.H. #124; thence along said highway right of way line South 308.20 feet to the point of beginning of the tract herein described; thence East 300.00 feet; thence South 180.00 feet; thence West 300 feet to the East 50 foot right of way line of Minn T.H. #124; thence along said highway right of way line North 180.00 feet to the point of beginning.

A part of the Southeast Quarter (SE%) of Section Sixteen (16), Township One Hundred Twenty-two (122) North, Range Thirty-two (32) West, described as follows: Beginning at the center of said Section 16; thence along the North line thereof East 50.0 feet to the right of way line of Minn. T.H. #124; thence along said highway right of way line South 488.2 feet to the point of beginning of the tract herein described; thence East 300.0 feet; thence South 180.0 feet; thence West 300.0 feet to the East 50 foot right of way line of Minnesota Trunk Highway #124; thence along said highway right of way line North 180.0 feet to the point of beginning.

Section 2. QUANTITY. The quantity of land embraced within the

foregoing description and bounded as described is approximately 2.43 acres, more or less.

Section 3. FILING. The City Clerk is hereby directed to file certified copies of the Ordinance with the Secretary of State, the County Auditor, and the Register of Deeds of the County in which the property is located and the Minnesota Municipal Commission.

Section 4. ZONING. The foregoing described property is annexed to the City of Paynesville and zoned within the City limits as Zone C-2, highway commercial district.


